
A BILL FOR AN ACT

To appropriate \$91,560,344 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2017, to provide funding for the operations of all branches of the National Government of the Federated States of Micronesia, its agencies, various programs, grants, subsidies and contributions, capital improvement projects, and other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title. The title of this act is as follows:

2 To appropriate the sum of \$91,560,344, from the General Fund of
3 the Federated States of Micronesia for the fiscal year ending
4 September 30, 2017, for the purpose of funding the operations
5 of all branches of the National Government of the Federated
6 States of Micronesia, its agencies, various programs, grants,
7 subsidies and contributions and capital improvement projects.
8 Of the total amount of funds appropriated herein, \$1,000,000
9 shall be deemed to come from funds available under the amended
10 Compact from the education sector; and \$300,000 shall be deemed
11 to come from funds available under the amended Compact from the
12 infrastructure maintenance fund (IMF); \$208,500 shall be deemed
13 to come from funds available under the amended Compact from the
14 health sector (arrears); \$1,900,000 shall be deemed to come
15 from funds available under the amended Compact from the private
16 sector development sector (arrears); \$1,612,620 shall be deemed
17 to come from funds available under the Supplemental Education

1 Grant; and \$9,498,100 shall be deemed to come from funds
 2 available under the amended Compact from infrastructure sector
 3 (arrears). The sum appropriated herein shall be apportioned as
 4 follows:

5 Section 2. Operating expenses of the Executive Branch.

16 Section 11. Reprogramming. Reprogramming of funds into
 17 or from the personnel budget line item shall not be permitted.
 18 The President, Speaker and Chief Justice may reprogram up to
 19 ten percent (10%) to or from the funds appropriated in sections
 20 2 (Operating expenses of the Executive Branch), 3 (Operating
 21 expenses of the Legislative Branch), and 4 (Operating expenses
 22 of the National Judicial Branch). Reprogramming of funds
 23 within a department, office or agency shall be effected by the
 24 head of such department, office or agency by specifying in
 25 writing to the Secretary of the Department of Finance and

1 Administration of the FSM National Government, the accounts for
2 which funding is either increased or decreased. Reprogramming
3 other than as specified herein is not permitted, and more
4 specifically, reprogramming into or out of any line item
5 contained in section 8 (Grants, Subsidies and Contributions) or
6 section 9 (Investment: Capital and Human Resources) is not
7 permitted. The President shall report to Congress within one
8 month of the last day of each financial quarter all amounts
9 reprogrammed inter or intra a department, office or agency.

10 Section 12. Allotment and management of funds and lapse
11 dates.

12 (1) General provisions.

13 (a) All funds appropriated by this act shall be
14 allotted, managed, administered and accounted for in accordance
15 with applicable law, including, but not limited to, the
16 Financial Management Act of 1979.

17 (b) The allottees shall be responsible for ensuring
18 that these funds, or so much thereof as may be necessary, are
19 used solely for the purposes specified in this act, and that no
20 obligations are incurred in excess of the sums appropriated.

21 (2) Allottees. The allottees of the funds appropriated
22 by this act are as follows:

23 (a) Section 2 - the allottee of these funds shall
24 be the President of the Federated States of Micronesia;

25 (b) Section 3 - the allottee of these funds shall

1 be the Speaker of the Congress of the Federated States of
2 Micronesia;

3 (c) Section 4 – the allottee of these funds shall
4 be the Chief Justice of the Supreme Court of the Federated
5 States of Micronesia;

6 (d) Section 5 – the allottee of these funds shall
7 be the Public Auditor of the Federated States of Micronesia;

8 (e) Sections 6 through 9 – the allottee of these
9 funds shall be the President of the Federated States of
10 Micronesia; PROVIDED, HOWEVER, that for the following
11 subsections of sections 8 through 9 of this act:

12 (i) Section 8, subsection (11)(a) through (d)
13 – the allottee of these funds shall be the Chief Justice of the
14 respective State Supreme Court;

15 (ii) Section 8(11)(j) – the allottee shall be
16 the President of the College of Micronesia – FSM;

17 (iii) Section 9(1)(a) through (c) – the allottee
18 of these funds shall be the President of the College of
19 Micronesia-FSM; and

20 (3) Lapse date. The authority of the allottees to
21 obligate funds appropriated by this act shall lapse as of
22 September 30, 2017; PROVIDED, HOWEVER, that the funds
23 appropriated under section 9 of this act shall not lapse.
