

Would be FSM bank owner arrested for fraud and other charges in the United States

Pohnpei, FSM—According to a news story published on March 15 by the Center for Public Integrity, Cary Lee Peterson was arrested in San Francisco by the FBI and charged with securities fraud related to a pro-Bernie Sanders super PAC (Political Action Group) that collected nearly \$50,000 from “James Bond” actor Daniel Craig. The article cites Justice Department Officials with the announcement.

The Bernie Sanders super PAC was not authorized by the Sanders campaign and in fact, the campaign’s chief legal counsel issued several cease and desist letters to Peterson that largely went unheeded. That fact was the subject of an interview with Peterson on Al Jazeera in February



a maximum penalty of 20 years for each charge and a maximum fine of \$5 million. Cary Lee Peterson has ties to the FSM and was in Pohnpei not long before his arrest in San Francisco. In Pohnpei he claimed to be

opening a bank with alleged local partner Senator Shelton Neth that he was calling the East America Bank. He was also behind a drive to establish a purported economic opportunity in the FSM for medical marijuana.

In late February, an article briefly appeared on the Pohnpei Government website that featured a photo of Peterson shaking hands with Lt. Governor Reed Oliver. Nearly anyone can organize a courtesy call with a government official but Peterson used the photo, which is still up on his Facebook page, to indicate that the Pohnpei State Government supported the idea of the East America Bank.

Pohnpei’s Chief of Staff Joseph Saimon was unaware of the article that published on the government website. The article was pulled down from the website within a matter of hours after we spoke to Saimon about it. Saimon said that someone would have a lot of explaining to do.

The article on Pohnpei's website said that on February 25, 2016 Peterson met with the Banking Board Chairman to "finalize" the formation of East America Banking Corporation, "a domestic bank that will enable local rural and social development, in addition to support(ing) a sustainable agricultural industry for industrial hemp that is thriving in the mainland U.S., which will flourish an ongoing harvest of medicinal cannabidiol oil (CBD) that will position itself as a new flagship commodity for FSM."

The unauthorized article claimed that "the talks on East America Development Program started last year and have perpetuated into a long-term agenda for Capital State to gain independence from foreign dependence for domestic issues as water supply, education, energy-efficiency, healthcare, and job creation."

This afternoon we checked with the Banking Board. Their representative told us that despite numerous invitations to do so, Peterson never filed any application to establish a bank in the FSM.

According to the FSM Department of Justice, Peterson also tried to establish a PAC for Micronesia. DOJ is in possession of the documents he filed.

While in Pohnpei, Peterson approached

Murphy Panuelo about the possibility of leasing space in his new building, the One World Plaza in Kolonia. Peterson told him that he wanted the space for the new headquarters of his new bank. Panuelo told him that since he was a stranger to him he would not lease him the space until he had checked his background and confirmed his bona fides with the U.S. Embassy.

Later that day, Peterson posted a photo on his Facebook page of himself standing in front of the One World Plaza with a caption that led readers to believe that the building was his and that it had been a project he'd been working on for about 18 months. A few hours after we contacted Panuelo to tell him about the photo Peterson removed it.

On a much smaller scale, it's the type of thing Peterson's been accused of doing many times before that has recently landed him in hot water with the U.S. Department of Justice. They accuse him of publishing false press releases and blog posts in addition to false revenue claims that overstate his corporate assets.



Peterson's Facebook page still has the misleading photo of him shaking hands with Lt. Governor Oliver. It also has several photos of Peterson with Senator Shelton Neth and representatives of other countries including Albania.

FSM Department of Justice Attorney Clayton Lawrence says that DOJ is actively looking into Peterson's activities while he was in the FSM. He said that tips from

people who had contact with Peterson while he was here would be appreciated.

Construction of Supporting Center for Persons with Disabilities in Pohnpei State

On March 28, 2016, the Grant Contract Signing Ceremony was held at the Pohnpei State Government Office for the Project for Construction of Supporting Center for Persons with Disabilities in Pohnpei State which provided Pohnpei Consumer Organization with US\$109,105 under Grant Assistance for Grass-roots Human Security Projects.



The objective of this project is to provide Pohnpei Consumer Organization with a new facility which will be utilized as a supporting center for persons with disabilities.

In the ceremony, Ambassador Masaki Sakai expressed his sincere hope that the supporting center would contribute to the improvement in quality of lives of persons with disabilities. Comparing Tokyo and Pohnpei, he showed his appreciation for the peaceful and family-oriented community in Pohnpei. On the other hand, he pointed out that the policies for persons with disabilities should be more individual-oriented to better serve all persons with disabilities, as a type of disability is different for each person. He expressed his hope that the new supporting center could promote such change. Mr. Nelbert Perez, President of Pohnpei Consumer Organization, said that the 2010 FSM census showed the FSM had approximately 11,000 persons with disabilities. He stated that the new facility would be a model for accessibility for those persons with disabilities in the country.

Grass-roots Projects in Kosrae State

On March 21, 2016, a grant contract signing ceremony was held at the Kosrae state government office for two grant assistance projects: the Project for Renovation of Baseball Ground in Kosrae State, and the Project for Procuring a Cesspit Cleaner Truck in Kosrae State. The former provides Kosrae Department of Education with US\$90,473 under Grant Assistance for Cultural Grass-roots Projects, while the latter provides Department of Transportation and Infrastructure with US\$96,940 under Grant Assistance for Grass-roots Human Security Projects.

Due to large rainfall and high temperature in daytime, it has been a challenge for the Kosraean community to find an enough space for sports and cultural activities. It caused social problems such as exposure to drugs and alcohol in under-age. The objective of baseball ground renovation project is to educate youth and strengthen community bonds by promoting sports and cultural activities.

The existing cesspit cleaner truck has been serving for the community for over 20 years, and has a number of trouble and damage. The latter project will provide Kosrae with a new cesspit cleaner truck, which will go around residential homes

and public buildings to vacuum human waste. The objective of this project is to provide sanitary and clean environment for approximately 6,600 people who currently reside in Kosrae.

At the ceremony, Ambassador Masaki Sakai gave a special remark and expressed his strong hope that those two projects will make a large contribution to improve people's livelihood in Kosrae. He also shared a heart-warming memory of his visit to all of the nine schools in Kosrae to make KIZUNA (strong bonds) presentations in December 2015. When he visited the Walung elementary school, students sang their school song which ends with a Japanese word, GAMBARE (work hard). Based on KIZUNA between people of the FSM and Japan and a spirit of GAMBARE, Ambassador Sakai expressed his hope to work together to make fruitful outcomes from the two projects.

The ceremony was witnessed by Governor Jackson, Lt. Governor Sigrah, Speaker Palik, Vice Speaker Taulung, Director of Education Dr. Waguk, Director of Transportation and Infrastructure Mr. Luckymis, and staffs of the Kosrae State Government.

Presented at the ceremony were Lt. Governor Reed Oliver, representatives of Pohnpei legislature, staffs of FSM National Government and Pohnpei State Government, and persons with disabilities.

Saipan—Four swimmers from the Pohnpei Swimming Club represented Pohnpei and the FSM at the Saipan International Swim Meet March 17-19. The three days of competition at the Kan Pacific Pool in Marpi, Saipan gave our swimmers an excellent opportunity to showcase their skills among some of the best swimmers in the region. The first day of competition resulted in a 1st place finish for 16 year old Kaleo Kihleng in the Men's 200 Meter Backstroke, 2nd place finish for 11 year old Nicole Adams in the Girls 200 Meter Breaststroke, and a 3rd place finish for 11 year old Kyler Kihleng in the Boys 200 Meter Backstroke. The team finished out the day with a 3rd place finish in the Mixed 200 Meter Freestyle Relay.

Friday was another day of stiff competition and saw our team start out the day with a 4th place finish for Kestra Kihleng and 6th place finish for Nicole Adams in the Girls 100 Meter Freestyle, 6th place for Kyler Kihleng in the Boys 100 Meter Freestyle, and 3rd place for Kaleo Kihleng in the Mens 100 Meter Freestyle races. Friday's session finished out with Nicole Adams placing 6th in the Girls 50 Meter Backstroke, Kyler Kihleng placing 4th in the Boys 50 Meter Backstroke, Kestra and Nicole placing 2nd and 3rd in the Girls 100 Meter Butterfly, and Kaleo Kihleng placing 2nd in the Mens 100 Meter Butterfly. The team enjoyed a second place finish in the Mixed 200 Meter Medley Relay.

Saturday was a full day of competition, starting early in the morning and lasting well into the evening. In spite of fatigue and some minor illnesses, the Pohnpei swimmers pulled through with some great races, finishing in the top 6 in every event they entered. Kestra Kihleng and Nicole Adams finished 2nd and 4th in the Girls 100 Meter Breaststroke, 2nd and 6th in the Girls 50 Meter Butterfly, 2nd and 5th in the Girls 50 Meter Breaststroke, and 3rd and 5th in the Girls 50 Meter Freestyle. Kestra also came in 2nd in the Girls 200 Meter Individual Medley. Kyler Kihleng placed 3rd in the Boys 100 Meter Breaststroke, 6th in the Boys 50 Meter Breaststroke, 3rd in the Boys 100 Meter Backstroke, and 5th in the Boys 50 Meter Freestyle. Kaleo Kihleng finished 1st in the Mens 50 Meter Butterfly, 2nd in the 200 Meter Freestyle, 2nd in the 200 Meter Individual Medley, and 3rd in the Mens 50 Meter Freestyle.

Along with the many ribbons the team brought home was a high-point trophy, awarded to 12 year old Kestra Kihleng as she tied for third place in the overall points earned in her age division.

Swimmers were also able to tour some of the sites of the island during the five days they were in Saipan. They also enjoyed the island's famous Night Market where the local entertainment performed a Pohnpeian song in honor of the team from Pohnpei.

The team returned from Saipan in high spirits and looks forward to representing Pohnpei in future competitions.

On February 24th, 2016 the Sokehs Municipal Government celebrated the anniversary of the Sokehs Rebellion that took place in 1911. More than 100 years later, we are still finding reasons to “rebel” in Sokehs. This year the theme was “Come Join the Rebellion” and the focus was on fighting against non-communicable diseases in Pohnpei. The 1911 rebellion was about regaining honor from the Germans who disrespected Soumadau en Sokehs and his men that were building a road in Sokehs. Today, NCDs are taking away our honor by taking away our health and weakening our bodies. To fight against this, the Sokehs Municipal Government sponsored a fun hike up Sokehs Ridge. The hike is steep and provided great exercise to those who went up. More than 300 people climbed the ridge that day and as a bonus, these people were the first ones to see the new World War II Memorial signs that have been installed on the ridge to detail what life was like in Pohnpei during the war. The SMG gave away 200 t-shirts and 200 pairs of Croc sandals donated by the Care Micronesia Foundation to the first 200 people who hiked the ridge, saw all 5 signs, and came back down to the municipal office. Expansion of preschool building for United Church of Christ Preschool

On March 28, 2016, a grant contract signing ceremony was held for the Project for Expansion of Preschool Building for United Church of Christ in Pohnpei Preschool in Pohnpei State which provided US\$176,277 for United Church of Christ in Pohnpei Preschool under Grant Assistance for Grass-roots Human Security Projects. The objectives of this project are to promote children’s welfare and to improve the environment for early childhood education through expansion of a preschool building. In his address, Ambassador Masaki Sakai emphasized the importance of early childhood education. He explained that the population in Japan had been gradually decreasing since it marked its highest population in 2010, and one of the

reasons for the reduction is that insufficient preschool and nursery facilities make it difficult for Japanese women to raise children while working. He expressed his sincere hope that the construction work would proceed smoothly and the expanded preschool building would be fully utilized to strengthen preschool education in UCCP Preschool. Followed by addresses, a grant contract was signed by Ambassador Sakai and Pastor Iuhfert Hainrick, Vice President of UCCP.

The ceremony was witnessed by Principal and Vice Principal of UCCP Preschool, and representatives of UCCP.

Tokyo – Speaker Simina was invited by the Government of Japan to attend the National Memorial Ceremony for the victims of the earthquake and tsunami of March 11, 2011. Speaker led a delegation from Congress paid courtesy calls on the Speaker of the Diet and exchanged views with Mr. Keiji Furuya, Chairman of the Japan-FSM Parliamentary Friendship League. Speaker Simina also visited disaster struck areas of Miyagi and Fukushima prefectures to view the progress of the reconstruction efforts.

During the week-long visit starting from March 6 and culminating in the national remembrance ceremony on March 11, Speaker Simina led a delegation of Congress consisting of:

and Legislative Counsel Lam Dang as staff

Joining the delegation were HE John Fritz, Ambassador of the FSM to Japan, and Kunio Suehara, Economic Attache.

The delegation started in Sendai in Miyagi Prefecture. Speaker Simina paid homage to the victims of the disaster at the Millennium Hope Hills, a memorial for the victims of the great earthquake, and discussed the details of the reconstruction of the area with the Mayor and officials of Iwanuma City, one of the worst affected by the earthquake.

Upon return to Sendai the delegation was received by Shuichi Miura, Vice Governor of Miyagi Prefecture. Speaker Simina conveyed his long held desire to visit the disaster struck areas of the Tohoku region

The following day the delegation traveled to Fukushima Prefecture where it was received by Masao Uchibori, Governor of Fukushima Prefecture. The delegation had an exchange of views regarding the disaster area. That meeting was widely reported in the press.

After the meeting the delegation received a briefing on the effects of radiation exposure due to the Dai Ichi Nuclear Power Plant, and the efforts at remediation. The delegation was impressed by the efforts to reduce substantially exposure and to clean up the environment.

The delegation went on subsequently to Iwaki City, 60 km from the Dai Ichi Power Plant. It was received by the Mayor and the Chairman of the City Council. Afterwards the delegation was taken to visit a museum of the disaster as well as the coastal areas that were devastated by the tsunami. The delegation was able to see for itself the extent of the devastation and the scale of the reconstruction efforts.

One highlight of the trip was a visit to an elementary school where the delegation was invited to join the students for lunch.

The delegation then went on to Tokyo where it met with national government leaders, including Tadamori Oshima, the Speaker of the House of Representatives. At the meeting the two speakers had an exchange of views regarding certain parts of Japanese grant aid the future of the FSM after 2023. Speaker

Simina described the efforts of the FSM in building up the FSM Trust Fund. Both sides exchanged views on the importance of fisheries to Japan and the FSM.

The delegation also had separate meetings with Keiji Furuya, Chairman of the Japan-FSM Parliamentary Friendship League, Masakazu Hamachi, Parliamentary Vice Minister for Foreign Affairs, and Yoshitaka Ito, State minister for Agriculture, Forestry and Fisheries.

The culmination of the trip was the attendance of the Speaker Simina, Vice Speaker Martin and Senator Moses of the official National Memorial Ceremony on March 11, in the presence of His Majesty the Emperor of Japan.

Speaker Simina also hosted a reception on March 10 for officials and friends of the FSM, where he delivered the following speech:

“Honorable Keiji Furuya, Chairman of the Japan-FSM Parliamentary Friendship League along with members of the Friendship League; Honorable Masakazu Hamachi, Parliamentary Vice Minister for Foreign Affairs; Ambassadors and friends from the Pacific Island Nations; the Ministry of Agriculture Forestry and Fisheries; and of course our dearest friends and supporters of the FSM;

Ladies and gentlemen;
I am honored to be among you this evening, and on behalf of my delegation and the people of the FSM, I bring warm greetings and welcome you.

My delegation and I are here by the kind invitation of the Government of Japan to attend the Memorial Ceremony of the Great East Japan Earthquake scheduled to be held tomorrow. In this regards I wish to thank the Government of Japan and especially the Honorable Keiji Furuya for providing us this opportunity.

Prior to this day, my delegation and I visited several cities of Miyagi Prefecture and Fukushima Prefecture of the Tohoku Region where we witnessed the still evident scars of the disaster of 5 years ago, as well as the positive progress towards reconstruction. During our visits we also had the privilege to meet with the Honorable Masao Uchibori Governor of Fukushima Prefecture; the Honorable Shuichi Miura, Vice Governor of Miyagi Prefecture; Mayor Hiroo Kikuchi of Iwanuma City; Mayor Toshio Shimizu and Speaker Shigeru Nemoto of Iwaki City; and Vice Mayor Yukimoto Ito of Sendai City.

Today I also had the opportunity to meet with the Honorable Tadamori Oshima, Speaker of the House of Representative, the Honorable Keiji Furuya, Chairman of the Japan-FSM and Japan-Pacific Parliamentary Friendship Leagues, and the Honorable Masakazu Hamachi Parliamentary Vice-Minister for Foreign Affairs – where we exchanged views on issues of great importance both on bilateral and regional levels. I wish to take this opportunity to thank the Government of Japan and the People for their commitment as a close partner to our economic development endeavors.

Since the disaster, I have been meaning to come to Japan to personally visit the affected areas, but due to obligations, I could not visit earlier. I am therefore pleased that my delegation and I were able to finally visit the affected areas on this occasion of the 5th Memorial Ceremony of the disaster. I wish to commend the hard work and dedication of the Government and People of Japan and pray for the full recovery of the Tohoku Region. We share some common difficulties with Japan as the Pacific Islands are also prone to natural disasters such as typhoons. In this respect, I wish to extend my sincere appreciation to Japan for their continued assistance on these occasions.

Once again ladies and gentlemen, my Delegation joins me in thanking you for joining us this evening.

DOMO ARIGATO GOZAIMASU.”

Speaker Simina on behalf of Congress invited Speaker Oshima and all the officials that the delegation met throughout the trip to visit the FSM. The invitations were warmly welcome.

The delegation left Japan on March 12.

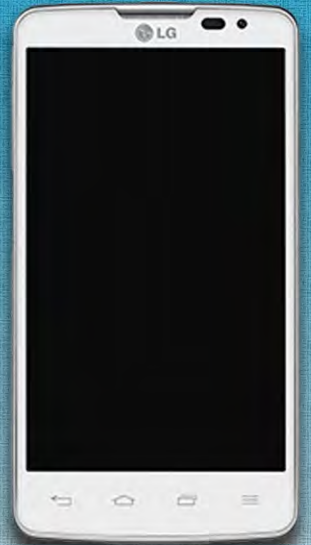

Trekking in the “Jewel of Micronesia” Introducing “MossMan”

Trekking into the rainforest to view the Menka Ruins on the stunningly beautiful island of Kosrae, Federated States of Micronesia, was one of those experiences which was surprisingly impressive and energizing. My husband and I met Salik Wakuk by the bridge in the small village of Utwe, Kosrae. He guided us to the Menka Trail down a bumpy dirt road. Having no idea where we were going or what we were about to see added to my excitement for the trek. The ruins were not noted in any research I had done on the island. The path through the rainforest was relatively flat but very challenging due to the wet and slippery terrain. Salik quickly crafted two walking sticks from the local forest for us. Annual rainfall is 5,000 millimeters per year in Kosrae, so we were destined to get wet. But no worry, the forest provides wonderful coverage.

We crossed the Menka River 5 times, sometimes walking on tree roots which were submerged underwater. The water was crystal clear. Salik explained to us that this was his family's land and that his grandfather had kept information about the ruins a secret until he eventually confided in Professor Emeritus Harvey Segal, a noted teacher and longtime resident of Micronesia, in the 1960's. Since that time, there has been more interest in the ruins and other archeologists have come and visited the site. However, the ruins have never become as popular as the nearby Lelu Ruins or the neighboring island's Pohnpei Nan Madol ruins. Our goal for the day was to visit the ruins but, as is so often happens, it is never the destination where the joy lies – IT IS THE JOURNEY. Salik was engaging and informative as he introduced us to native plants of the rainforest, rich with food, tools, medicine and sheer beauty. Come join us for the walk.

We were first introduced to the Ka Tree (*Terminalia Carolinesis-Combretaceae*) considered endemic only to Kosrae and its neighboring island, Pohnpei. It is a tall (up to 28 meters), straight, highly valued and remarkably strong tree with a fluted trunk at the base that may be several meters above the ground and can stretch out 10 meters. The straight trunks

are a major source of wood for building canoe hulls which are an integral part of the Micronesian culture. Ka is also used for house construction and is a source of medicine. Additionally, if ever lost in the forest, you can pound the root with a rock and alert others of your plight because it resonates like drums in the forest. Above you see a family of Ka's interconnected to one another.



So let's say I have my canoe, but as any boater knows, time will come for the inevitable leak and need for repair. Again, the forest delivers. Salik introduced us to the “acid tree” which produces a natural caulk. When you peel off the bark, the tree produces an epoxy type material which is mixed with local “lapa soil” producing a caulk which can be used to repair many things, including canoes.

Time for a rest on the bamboo bench Salik built along the trail. Giant bamboos are the largest members of the grass family. Think of it, certain species of bamboo can grow 3 feet in a 24 hour period at a rate of almost 1.5 inch an hour. They are of notable economic and cultural significance and used as food (in Nepal a delicacy; in Indonesia, as a spice; pickled; sweet wine), medicine, construction (scaffolding), writing surface, weapons, fishing lines and musical instruments.

While resting, Salik demonstrates the use of the red round fruits, locally called “Srifac” which are found all over the forest floor. These fruits eventually dry out and can be eaten. They taste like walnuts. Delicious!



Another delicious and nutritious plant caught our attention – see the stunning Fiddlehead. These furled fronds of young fern can be harvested for use as a vegetable. Fiddleheads have antioxidant activity, are a source of omega-3 and omega-6 fatty acids, and are high in iron and fiber. The fiddlehead resembles the curled ornamentation (called a scroll) on the end of a stringed instrument, such as a violin. They are majestic plants.

Ginger is a beautiful forest flower in bright pink with white trim. But don't be fooled by its beauty – it is much more than an ornamental flower. It has a long history of being used in lots of medicinal



treatments. The root or stem, known as the rhizome, is packed with phenolic compounds that help improve the digestive system when consumed regularly. Ginger also reduces nausea and muscle pain from those long canoe rides. It bolsters your body's immune system to combat the common cold, flu and other similar problems. Locals also use the ginger leaves to wrap fish in before putting on the fire resulting in a moist, delicious grilled fish.



And, now for a heavy hitter – the medicinal plant of Noni (*Morinda citrifolia* L) which has been used in the Pacific region for over 2000 years. Everyone has heard about Noni as it is commercially available all over the world. Noni was one of the those plants that Pacific Islanders brought with them in their canoes when they migrated from their native land years ago. Salik said that verbal history given to him has him keeping the plant in a jar for a few days until the plant softens. The plant creates a horrible stench and is difficult to ingest. However, he states the one time he did this, his nasal passages opened widely and his sense of smell increased considerably. There are many scientific papers on noni and this particular treatment method is noted to be quite effective for joint pain and arthritis.

As we continued our hike, I encountered a different type of problem – a broken camera strap. No – not to the internet or the local hardware store, the forest provides. Known locally as “lo” the Beach Hibiscus (*Hibiscus Tiliaceus*). The wood is used for canoe parts, crafts, and fuel wood.

The fibrous inner bark is utilized for cordage and parts of the plant are used medicinally. Beach hibiscus is culturally significant throughout the Pacific.



colored bark draws immediate attention. Patches of outer bark are shed annually at different times, showing off their bright green inner bark. These patches then darken and mature to give blue, purple, orange and maroon tones. This continual peeling results in vertical colorful streaks of bright blues, greens and orange.

After a couple of hours, alas we come to the hidden ruins. The ruins consist of hundreds of two rectangular parameters built from rocks piled together. The parameters are approximately 10 x 12, some being larger. The one parameter consists of only the outer rock formation but the second structure (or room) has an inner pile of rocks built up about 1 meter in the center. Historians note that visitors to Kosrae in the 1800's spoke with local elders who knew some English and were good informants. The Menka ruins are similar to religious structures found

in other Pacific islands. Salik says that it appears the structures are from the 12th Century BC at which time Micronesians practiced ancient religious ceremonies. Three gods in particular were served by a group of priests: Sinlanka, the breadfruit goddess and her husband, Nosrunsrup, god of thunder, and Sikaus, associated with many taboo places. I asked Salik what he believed would be “taboo” places. Salik stated that at times the priests would sit in a circle and drink kava. Salik thought long and hard and I think perhaps I was invading on private space. Eventually, Salik stated that there were rituals – often involving kava – practiced by people often involving flesh cutting.

As we sat surrounded by these mystical ruins deep in the rich green, lush forest, I imagined what living here would be like centuries before. All I needed was right here – nourishment for the body, clean water for bathing and drinking and various woods to build with and keep me dry. Plants were medicinal should I become ill. I imagine that with the limited knowledge of the world of that day, it would be easy to believe that the gods were somewhere “out there” providing for me and my family. So, as we said goodbye to Salik, I felt grateful to be living on this wonderful planet and was reminded again of the need for environmental protection and global conservation. Thank you Salik for the gift of your journey and sharing a part of your history with me..

Coast Guard coordinates, assist search efforts for 9 missing boaters on 3 separate cases in the Pacific

U.S. Coast Guard 14th District Public Affairs

HONOLULU — Coast Guard and AMVER crews rescued three boaters in the waters between Chuuk and Puluwat Atoll, Federated States of Micronesia, Wednesday. An HC-130 Hercules aircraft crew from Coast Guard Air Station Barbers Point on Oahu, located three additional boater missing near Tarawa and are coordinating their rescue by a commercial vessel and the same Hercules aircraft crew has been diverted to search for an additional vessel also with three boaters overdue near Tarawa.

In the third case Coast Guard watchstanders in Honolulu are coordinating with search and rescue controllers at RCC Fiji to search for an overdue 18-foot skiff with three boaters aboard reportedly left Tarawa en route Maiana on a fishing trip. The Coast Guard C-130 aircraft that searched on the second case has been diverted to begin searching the area. The missing 19-foot skiff is three days overdue on their return from fishing near Maiana.

In the first case, three boaters, several days overdue on a voyage from Chuuk to Puluwat Atoll, in the Federated States of Micronesia are safe in Puluwat Atoll, Wednesday, following a joint international search. The missing men were on a 19-foot skiff and located by the motor vessel Shoryu. All three men were brought aboard the Shoryu and are reportedly to be in good condition. The skiff was placed in a side tow and the Shoryu took the three men to Puluwat. A family member reported the men overdue Monday, prompting a search by the Coast Guard. Watchstanders at Coast Guard Sector Guam issued an Urgent Marine Information Broadcast alerting mariners in the region to the situation. The watchstanders coordinated search efforts of two Automated Mutual Assistance Vessel Rescue System ships: the Soma Maru and Shoryu and provided search patterns for each vessel.

"We sincerely appreciate the support and coordination of all our search and rescue partners. Due to the size and scope of the Pacific we depend on them to help us respond in a timely manner in remote locations," said Petty Officer 1st Class Dustin Welch, a search and rescue controller at Coast Guard Joint Rescue Command Center Honolulu. "We also recommend to all boaters to be prepared for unforeseen interruptions in their voyages by being prepared with extra supplies and communications devices."

In the second case near Tarawa, a Hercules aircraft crew located three boaters, missing for 8 days, just before noon, Wednesday. They dropped supplies from the plane to the boaters and the Coast Guard is working to identify a vessel in the area to relocate and rescue them. Watchstanders at the Coast Guard Joint Rescue Command Center in Honolulu were notified Monday, by search coordinators with the Rescue Coordination Center Nadi, Fiji, of an overdue 17-foot white and yellow skiff. The vessel reportedly had a 40 hp engine with 18 to 20 gallons of fuel on board and some fresh water. The skiff was reportedly last seen the morning of March 22 departing Teoraereke Village, Tarawa, en route a fishing area 10 miles to the south. A Royal New Zealand Air Force P-3 Orion airplane crew completed a search Saturday with no sightings. The Coast Guard provided the Hercules aircrew Tuesday. Due to the distance the crew covered to get to the search area, roughly 2,400 miles the distance from Los Angeles to New York City, they were able to search for 1 hour on scene before needing to land for crew rest and to refuel. Their search resumed Wednesday at first light.

Mariners are reminded a properly registered electronic position indicating radio beacon can make a dramatic difference not only in being located, but in the amount of time spent at sea. EPIRBs use satellites, not line-of-site like VHF radios or cellular towers, increasing their range and reliability. They're highly accurate and once activated provide rescuers with excellent location information for anyone in distress, significantly reducing on scene search time.

AMVER, sponsored by the Coast Guard, is a computer-based, voluntary global ship reporting system used worldwide by search and rescue authorities. With AMVER, rescue coordinators can identify participating ships in the area of distress and divert the best-suited ship or ships to respond.

Pacific media commits to stronger reporting of Tuna stories

KOROR, 24 MARCH 2016 (TIA BELAU) —The Pacific media practitioners gathering in Palau this week agreed to step up commitment "to stronger, better reporting for enhanced awareness of the importance of sustainable tuna fisheries to Pacific futures."

Journalists from American Samoa, Federated States of Micronesia, Fiji, Palau, Papua New Guinea, Solomon Islands and Vanuatu have met this week as part of the 4th Pacific Media Summit hosted by the government, media partners and people of Palau.

Their two-day Fisheries Forum Agency (FFA) Tunanomics Pacific Media Initiative Regional editors dialogue on 'Reporting the Future of Fisheries – challenges to 2020' comes two years after the launch in February 2014 of the FFA Tunanomics Pacific Media Initiative at the 3rd Pacific Media Summit in Noumea, New Caledonia.

The journalists expressed success stories and challenges in covering tuna stories and came up with recommendations that would make fisheries stories more attractive to its readers.

One of the recommendations is "to develop and grow their understanding of Tunanomics and what the economics of tuna mean to policy and decision makers, not just to news makers."

In Palau, although offshore fishing contributes less than five percent of the Gross Domestic Product (GDP), Palau is taking a different approach, by conservation and beefing up its marine surveillance capacities through its new national marine sanctuary.

However in terms of news report on tuna, it has never gained so much attention internationally until the move to declare 80 percent of Palau's EEZ as a marine sanctuary with 20 percent dedicated to domestic fishing.

Pacific media also agreed to strengthen coverage to the human aspect of sustainable tuna fisheries, including the eyes of island communities and the fishers taking the resource.

In other nations in the Pacific, policymakers themselves to be educated on tuna fisheries and this can be done with public debate and awareness of this topical issue, through popular platforms such as talkback radio filmed for TV.

Media members from other island nations also lauded Palau's marine sanctuary law and efforts to include its local communities in revenue sharing from the tuna economy.

FFA ponders options for new US tuna treaty

KOROR, 24 MARCH 2016 (RNZI) ---A working group of the Pacific Island parties met last week with the United States to hammer out some options for a possible structure for the US Pacific Tuna Treaty.

The interim treaty, which allows US purse seiners to fish in the Exclusive Economic Zones of island countries, is to expire at the end of December

The Director General of the Forum Fisheries Agency, James Movick, told Pacific journalists at a workshop in Palau, that the small working group and the United States reps came up with several options for the treaty.

These would be presented to the full group of Pacific Fisheries Ministers and also by the US reps to their industry group.

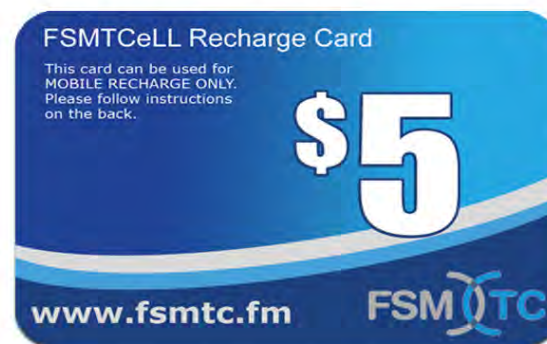
Movick said it is hoped that by July there will be a proposed treaty in place.

He didn't disclose the options but said there was a good exchange, and by having a small informal group, the exchange was freer flowing.

Education Corner:

Richard Womack, Ed.D

In the last KPress the EC promised to finish up this edition with how we might motivate our Pohnpei teachers and inspire them to improve. We explained that while teachers said they would be motivated if they were paid a higher salary—higher salaries are really not in the future. The readers must forgive EC—there will be no final answer this week as promised. But there are the beginnings. Last issue ended with:

“We can never improve student learning until we improve our teachers and motivate them to be better.

We will continue next EC and remember it's a simple idea-motivation. It is just getting someone to do something. People either do things because they want to do something or they have to do something. People are motivated by success and not motivated with failure. People are motivated to fulfill wants and needs. People have difficulty deciding what are wants and what needs are. There are always more wants than needs and usually more needs than resources. Exploring these ideas next issue will help us some (I think) unravel how to inspire and motivated our teachers. At least I hope so.”

Recall all of this began when we looked at the idea of On-going Teacher Training or the constant updating of knowledge

and skills by our Pohnpeian Teachers. We mentioned this was what the Pohnpei Department of Education wanted to do—that is put together a program where all the teachers have the opportunity to always be improving. We have noted that this on-going education is a hallmark of every profession from medicine to law and from engineering to education. But how do we inspire or motivate the teachers when we are reminded of the EC reader who said “I have a friend who is a public school teacher and like many of her colleagues is suffering from depression as a result of a lack of inspiration and motivation; low/poor pay and an insecure tenure with the new short term contracts now in place, being a major factor.”? Whatever we did we knew many teachers did feel this way and inspiring such teachers would not be easy.

To start the PDOE wanted to know in where the teachers would benefit most in the science and social studies they are required to teach yet have not had any coursework their own teacher training. For this task PDOE contracted Womack and Associates (2015) to test all the elementary school teachers and survey all the curriculum materials to see if there were enough for their

students. Once again this was done only for the sciences and the social studies. But as we said we already knew the teachers were insecure and many viewed the contract with suspicion. Many saw it as a control device put in place because PDOE did not feel that teachers were doing a good job. With this suspicious attitude how could we get the teachers to embrace On-going Teacher Training---something that would take even more of their time? If we tested the usual way we must test every teacher on what they are supposed to teach. This would mean usual tests on the content of Science as Inquiry; Physical Science and Technology; Earth and Space Science; Life and Environmental Science; Marine Science; Economics; Civics and Government; History; Geography and Culture. But since we already know that teachers will fail subjects they have not had, why try? Why prove something we already know? Why test teachers in a way that is embarrassing when teachers are already fearful. Therefore we devised what was called the Comfortability Test. We simply stated standards they were suppose to teach and asked how comfortable each teacher was teaching in the ten (10) areas/

subjects required. When the tests were scored each teacher signed a letter to their principal asking for training.

“Socrates was wise because he knew he was not wise”

Step One: Make It a Priority

The famous saying “what we pay attention to grows” is very true when it comes to professional development and being a lifelong learner. We have to make it a priority! If we aren't learning and pushing ourselves to get better, how do we expect others to follow suit? Our Pohnpei Principals should take pride in being an instructional leader. We firmly believe that the only way we can continue to lead is to constantly seek out opportunities to grow and learn. We owe it to ourselves, we owe it to those we lead, and, most important, we owe it to our students to be the best possible educators we can be. Personal growth is never ending. Just as we encourage and demand growth from our students, we should encourage and demand growth in ourselves. Life is a continuous improvement process.

We will keep at this topic until we get further answers---but a good start is the teachers asking for training. This is a very powerful way to show we are sincere in improving. womackandassociates765@gmail.com

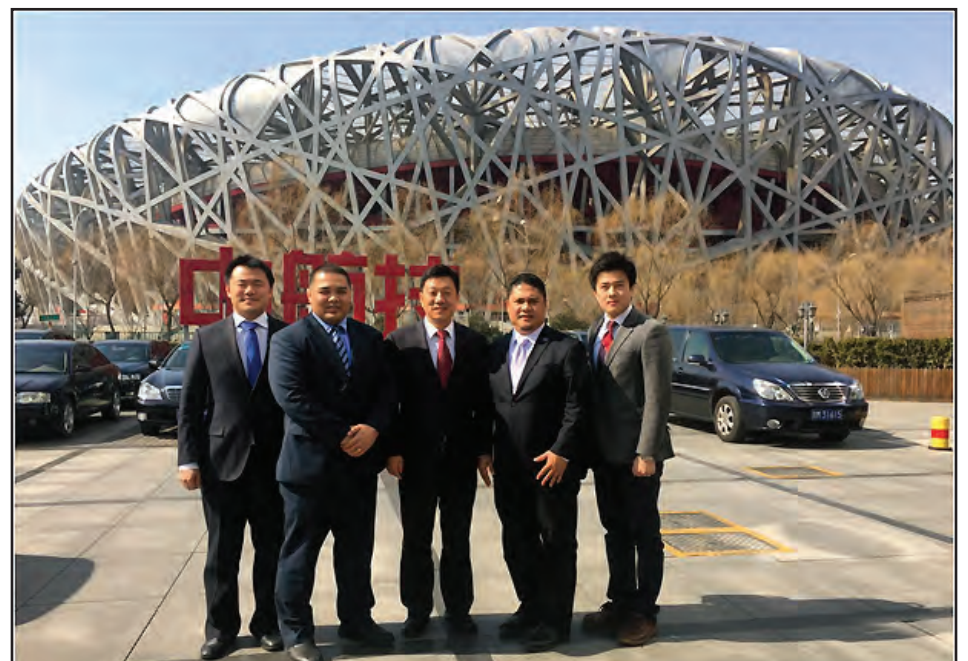
