## Pacific Island and Washington Leaders in a PICL

**Pacific Island Council of Leaders (PICL) Meet for the First Time in Washington D.C.**

Washington, D.C. (April 6-9)

– According to Assistant Secretary of State, Bureau of East Asian and Pacific Affairs, Christopher R. Hill, the State Department suggested to Pacific Island leaders in a previous meeting of the Pacific Island Council of Leaders (PICL) that they could meet directly with U.S. agency directors if the meeting was held in Washington, D.C. The leaders who meet on a tri-annual basis accepted the proposal and on April 6-9, Pacific Island leaders converged on Washington for high level multi-lateral talks. The talks are normally held in Honolulu. This year marks the first time that the meetings have

been held in Washington, D.C. in the organization's 26 years.

The PICL does not produce a list of resolutions as its purpose is to provide high level leaders in the Pacific the opportunity to talk freely about issues that affect them. It is facilitated by the East West Center, housed at the University of Honolulu in Hawaii and the secretariat of PICL.

The council does produce a communiqué at the end of the talks that covers the issues discussed. According to that communiqué, twenty Pacific Island leaders were in attendance. The communiqué says that the nations of the Pacific Islands encompass one-third of the globe.

The Twenty island leaders in

attendance represented American Samoa, the Cook Islands, the Federated States of Micronesia, Fiji, French Polynesia, Guam, Hawai'i, Kiribati, the Marshall Islands, Nauru, New Caledonia, Niue, the Northern Mariana Islands, Palau, Papua New Guinea, the independent nation of Samoa, the Solomon Islands, Tonga, Tuvalu, and Vanuatu.

According to the PICL communiqué, the purpose of the meetings in Washington was to broaden and deepen the Pacific Islands region's engagement with the United States. High level meetings were held with the Executive and Legislative Branches of the U.S. Government. The Council discussed a wide range of

issues including economic development, security, trade, aid, environmental protection, climate change, fisheries, emergency responses to natural disasters, USAID and the desire to expand U.S. public diplomacy programs, especially those of an educational and exchange nature. The PICL agreed on the need to strengthen the Joint Commercial Commission (JCC) by securing additional resources to fund the programs for developing trade and investment, and by revamping the agreement to improve market access for Pacific Island countries' exports, an issue the body has discussed before.

## US Secretary of State Addresses Pacific Island Leaders

**Washington D.C. (May 7, 2007)** - Assistant Secretary of State, Bureau of East Asian and Pacific Affairs, Christopher R. Hill said that he had visited many of the Pacific island states as he opened the morning meeting held at the Loy Henderson Conference Room at the State Department for the Pacific Island Conference of Leaders. Hill who has been involved in state visits to Korea and other countries that are or may be going nuclear said, "It's great to go to a place that isn't producing nuclear weapons." He went to speak on an invigorated engagement in the Pacific and the connections that all of our countries have.

U.S. Secretary of State Condoleezza Rice took the podium and welcomed the leaders especially Governor Linda Lingle of Hawaii, Governor Camacho from Guam, Lieutenant Governor Sunia from American Samoa, and Representative Tenorio representing the Commonwealth of the Northern Marianas.

She said, "There's another connection and one of great pride for us." Citizens of the Freely Associated States are able to serve in the military and some have made the ultimate sacrifice by giving their lives in that service. "The United States is grateful for their service."

"This meeting is a key event in what we are calling the Year of the Pacific. You will hear this phrase many times this week, but it encapsulates our efforts to expand our engagement with your countries and to reaffirm America's historic role in the

Pacific. Maintaining security and stability in the Pacific region is crucial to the interest of every country and every territory represented in this room, including the United States. Many of your countries face growing political, environmental, and economic challenges and these are often compounded by other more long term transnational threats. They pose profound threats to the Pacific Islands.

"In response to these challenges, we are working together to chart a comprehensive approach, promoting opportunity and prosperity, good governance and the rule of law, greater peace and security. You will hear

more about our plans throughout the day. We also plan to highlight the potential economic benefits that will result from the relocation of U.S. forces from Okinawa to Guam.

"I stress this comprehensive approach for an important reason, because we all know and share the conviction that democracy plays a key role in fostering political and economic development. Like many of you, the United States is deeply concerned about the unlawful overthrow of the freely-elected government in Fiji. We are very pleased that Pacific countries have spoken with one voice through the Pacific Islands Forum in calling for the speedy return of democracy to Fiji. The Pacific cannot devolve into where strong men unilaterally decide the fates of their country and destabilize democratic foundations of their neighbors.

"Let me close by thanking each of you for traveling to this

### Pacific Island Leaders Gather at the National Geographic Society

*The Elite of Pacific and United States Leadership Gather for a Pacific Night*

The representatives of the Pacific Islands Conference of Leaders (PICL) and the elite of the United States Government mingled together on Wednesday night at The National Geographic Society in Washington D.C. for a special celebration called the Pacific Night. U.S. speakers included Secretary of the Interior Dirk Kempthorne and a late visit by the third most powerful person in the U.S. Government, Speaker of the House Nancy Pelosi. Papua New Guinea Ambassador to the U.S. Leslie Rowe was the master of ceremonies for what was a sometimes humorous evening.

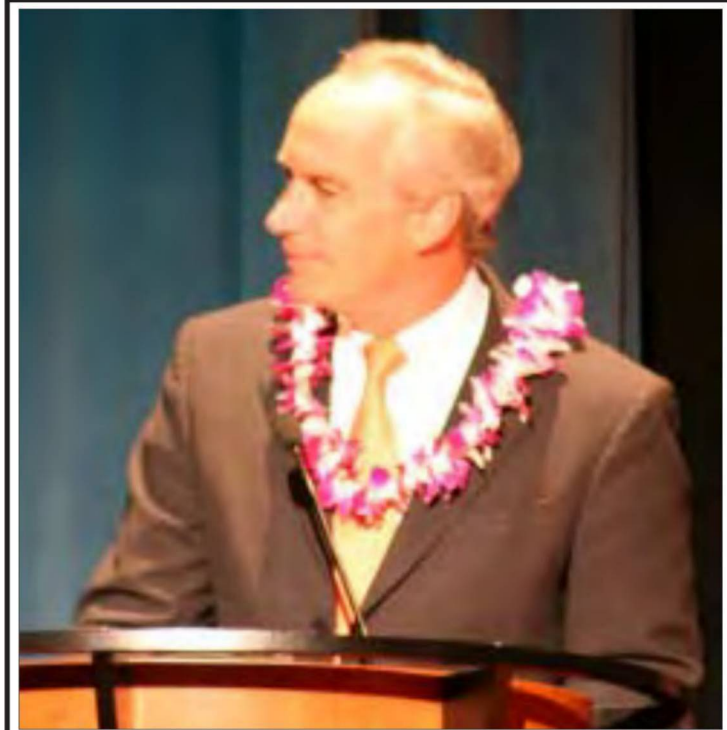
Many of the Pacific Islands leaders missed the opening moments of the evening for a briefing by Ambassador Karen Hughes, the U.S. Undersecretary

of State for Diplomacy and Foreign Affairs. During the briefing of the high leaders of the Pacific the Ambassador stated the U.S. intention of “affirming and expanding” their engagement in the Pacific Islands, a common theme of the U.S. heard throughout the PICL in what has been proclaimed to be the “Year of the Pacific”.

Though that doesn’t necessarily mean more money for the Pacific Ambassador Hughes did say that the U.S. would very soon, open a new Public Affairs office in Suva, Fiji. She also said that they would expand academic programs in the islands and may reinstate programs for education that have either lain dormant or been canceled outright.

Hughes, in speaking of the U.S. commitment to better com-

## FSM and MCT Sign Historic Agreement for Conservation

*Development funds provided by European Union to help raise capacity of NGOs in the nation.*

PALIKIR, Pohnpei – An agreement was reached on April 27 between the FSM national government and the Micronesia Conservation Trust (MCT) utilizing a portion of environmental funds from the European Union's 9<sup>th</sup> European Development Fund (EDF9).

The EDF9 provides 9.4 million Euros to the FSM for 2007, 719,000 of which will be utilized for an environmental program known as the Conservation and Environmental Protection Programme (CEPP). The CEPP will be administered and implemented by MCT, a trust char-

tered in 2002 by the FSM, leading local environmental NGOs, and The Nature Conservancy to support environmental sustainability. MCT also provides funding and technical support to the Republic of the Marshall Islands, and Palau.

In a letter to the EU, Rose Nakanaga, the National Authorizing Officer for the FSM and Assistant Secretary of Investment Management and International Finance, called the agreement with the EU a "landmark accord" that is a big step in helping the FSM "realizing our sustainable development goals, as well as continue to build the capacity and livelihoods of our

non-state actor sector and communities."

Assistant Secretary Nakanaga also noted that the FSM is pleased to be partnering with MCT in the implementation of the community focused project in the coming years because of its experience and technical ability in managing funds, and helping NGOs and community groups develop the skills to write proposals and reports.

The CEPP will focus on communities and community-led management initiatives and roles, a stipulation that the national government has supported in reaching an agreement with MCT to implement the program and disburse the funds to potential proponents, starting in May 2007. The funds will be primarily aimed toward raising the capacity of such groups to "formulate and deliver environment protection and conservation projects," according to the agreement reached by the EU and FSM.

Activities undertaken as part of the CEPP will be in line with several themes of the FSM's *National Biodiversity Strategy and Action Plan*, developed in 2002, including *Theme 1: Ecosystem Management*, and *Theme 8: Human Resources and Institutional Development*.

In many ways, it is the opening of a new chapter for the national government of the FSM, which has traditionally worked along government to government lines (national to state) in

such matters. It follows the growing trend of internationalization and coordination between both government and non-government organizations (known also as non-state actors or NSAs) to assist communities in the region.

According to Willy Kostka, MCT Executive Director, the Trust will use the funds to serve as a "financing mechanism" for the vaunted and ambitious Micronesia Challenge, the implementation of the Nationwide Protected Areas Network and the NBSAP, all ongoing conservation schemes for the FSM.

"The European funds will allow us to turn these ideas into real initiatives that benefit our local communities," Kostka added.

The EU, in developing the CEPP since 1997, according to its Financing Agreement with the FSM, said it realizes "the need for patient and sustained engagement with all community stakeholders over an extended period of time, and the need for the intervention to result in quick, demonstrable, successes, which serve to reinforce the value of joint community based action."

The Financing Agreement between the EU and the FSM marks the first time that the two federations have signed an accord. It signifies a major step in terms of bilateral relations, trade, and support.

**START OF CASE.** An application for discharge of debts under chapter 2 of the Bankruptcy Code has been filed in this court by or against the person named above as the debtor, and an order for relief has been entered. You will not receive notice of all documents filed in this case. All documents filed with the court, including lists of the debtor's property, debts, and property claimed as exempt are available for inspection at the office of the clerk of the court.

**CREDITORS MAY NOT TAKE CERTAIN ACTIONS.** A creditor is anyone to whom the debtor owes money or property. Under the Bankruptcy Code, the debtor is granted certain protection against creditors. Common examples of prohibited actions by creditors are contacting the debtor to demand repayment, taking action against the debtor to take money owed to creditors or to take the debtor's property, and starting or continuing foreclosure actions, repossessions, or wage deductions. If unauthorized actions are taken by a creditor against a debtor, the court may penalize that creditor. A creditor who is considering taking action against the debtor or the debtor's property, consult 31 F.S.M.C. 106 and may wish to seek legal advice. The office of the clerk staff is not permitted to give legal advice.

**LIQUIDATION OF THE DEBTOR'S ASSETS.** The Receiver will collect the debtor's property and turn any that is not exempt into money. If the Receiver can collect enough money and property from the debtor, creditors may be paid some or all of the debts owed to them.

**PROOF OF CLAIM.** Except as otherwise provided by law, in order to share in any payment from the estate, a creditor must file a proof of claim by the date set for above in the box labeled "Filing Claims." The place to file a claim, either in person or by mail, is at the office of the clerk of court. Proof of Claim forms are available at the clerk's office at any FSM Supreme Court.

## Yap State Leaders briefed on outcome of national Fuel Task Force meeting

COLONIA, Yap – Yap State Representatives to the national Fuel Task Force (FTF) held a briefing session with State Leaders. Highlighted in the briefing was extension of Mobil land lease agreements with Yap and Chuuk States for a period of three months

ending September 30, 2007. Mobil Oil Micronesia, Inc (MOMI) has agreed to the extensions as renegotiation of future fuel supply arrangements continues.

Options of purchasing MOMI's assets were also discussed during the recently con-

cluded FTF/MOMI meeting in Chuuk. The leaders were also informed of other urgent tasks for FTF in the next few months which include hiring expert/consultant to assess environment and structural remedies of fuel plants throughout the nation.

Also discussed during the briefing was Continental cargo embargo on Yap State which will

kick into effect on 16 June 2007. Leaders were informed that the needed fuel tanks purchased abroad are currently being refitted to meet Mobil's requirement. While it is uncertain when the tanks will arrive, the State is looking into ways to get them on island soon.

## FSM Opens Embassy in China

Beijing, CHINA - The Government of the Federated States of Micronesia recently dispatched a delegation to open the FSM Embassy in China.

The delegation, headed by Mr. Carlson D. Apis of the Department of Foreign Affairs arrived in Beijing, China on 25 April 2007 and on 27 April 2007, Mr. Apis, presented his credentials to the Ministry of Foreign Affairs as the Chargé d'Affairs, a.i. for the new resident mission in Beijing.

The Federated States of Micronesia and the People's Re-

public of China established diplomatic relations on 11 September 1989. After seventeen years of close cooperative relations, both governments dubbed the relations a "model relationship", a description that characterizes the prevailing relationship between the FSM and China. Building on this model relationship, H.E. President Joseph J. Urusemal decided to take this relationship to new heights by opening an Embassy in Beijing. The People's Republic of China currently has an embassy located in Palikir, Pohnpei.

The FSM Embassy is located at the Jianguomenwai Diplomatic Compound in Beijing. The exact address for the Embassy is as follows:

Mr. Apis, formerly the Deputy Assistant Secretary for Asian Affairs, now serves as the Chargé d'Affairs, a.i. while His Excellency Kasio E. Mida is the FSM

Ambassador Extraordinary and Plenipotentiary to China, cross accredited from his resident post in Tokyo, Japan.. The 15th FSM Congress will be considering during their upcoming sessions the President's 2008 Fiscal Year Budget which includes funding for a resident ambassador and a first secretary for the Embassy.

Mr. Apis was accompanied to Beijing by Mr. Edigar Isaac, Assistant Secretary, Department of Finance and Administration and Ms. Elsiner Yarofaisug, Administrative Officer, Department of Foreign Affairs to assist in the administrative set up of the Embassy.

## Regional Workshop on Forest Genetic Resources Conservation and Management in the Pacific

The conservation and management of forest genetic resources has been a major concern in the Pacific region. The significant loss of biodiversity due to destructive human activities associated with mining, agricultural clearing and commercial logging, particularly within the larger Melanesian countries, has featured in many international forums where issues like extreme poverty, climatic changes and environmental degradation are now the main focus of concern. It has become a major economic and environmental issue as to whether these countries can justify the present rate of exploitation of their forest resources. Several commercial timber species have become rare due to indiscriminate logging while many culturally valuable species are threatened by heavy harvesting for traditional uses such as wood carving, firewood and medicine.

The Pacific forests and trees are increasingly threatened in many ways including over-utilization, land-use change and climate change.

In 1999, a workshop was jointly organized and supported by the South Pacific Regional Initiative on Forest Genetic Resources (SPRIG), AusAID, FAO, the Pacific Islands Forests and Trees Support

Programme of SPC, SPREP and the Forestry Division of Samoa which developed the "Pacific Sub-Regional Action Plan for Conservation, Management and Sustainable Use of Forest and Tree Resources." The Action Plan is organized into four themes, as follows: Tree Species Priorities for Genetic Resources Operations and Activities; Conservation, Sustainable Use and Management of Forests and Trees; Germplasm Collection, Exchange and Access; and Institutional Strengthening, Training Needs and Regional Collaboration.

The Workshop to be held on June 25 - 29 in Nadi, Fiji, will aim to update the Action Plan developed in Apia in 1999 after assessing progress in its implementation over eight years. The revised plan will provide an agreed framework which suits the needs and priorities of each PCITs in relation to forest genetic resources conservation and management. FGR priorities for each country will be strongly linked to its wider development priorities. Although there has been a notable increase of interest among PICTs in developing research and action plan on FGR, there have been modest achievements due to management and governance issues, limited national budgets and shortages

One of the issues discussed at great length was the U.S. military's partial move from Okinawa into Guam. The move will mean an increased population in Guam of approximate 35,000 people, a few more people than currently live in Pohnpei.

The East-West Center, the Secretariat of PICL has been charged with the task of research and analysis on issues surrounding the move for the leaders.

Some U.S. leaders say that the move will mean increased economic development not just in Guam but across the Pacific Island Nations.

In a question and answer session at the Department of Interior officials said that the move to Guam could benefit islanders in several ways. Skilled construction workers could potentially get jobs working on the construction projects in Guam. It would require workers to relocate to Guam. Despite the current diaspora taking place in the islands (people departing from home islands to other places) officials conjecture

that there will be benefits to other islands besides Guam in terms of money sent to hired workers' homes.

Island contractors will be able to bid on jobs that will be required as part of the \$8 billion budget that is earmarked for the move.

The officials at interior said that "all of those people will need to go somewhere on the weekend." Since other island nations are all accessible by air from Guam perhaps the soldiers and their families will travel and by doing so help the economies of the islands they visit.

Palau President Tommy E. Remengesau said in roundtable discussions with Ambassador Karen Hughes, the U.S. Undersecretary of State for Diplomacy and Foreign Affairs, "No matter how big or small, it's the thoughts behind the deeds."

He expressed his concern however, that nuclear missiles from North Korea can reach Guam. That thought seemed to weigh heavy on the minds of the Pacific leaders.

The Kaselehlie Press asked then Vice-President Redley Killion what the best thing about PICL was in his consideration. He

quickly said "The military base in Guam" and referred to the possible economic impact in the Pacific

Killion also said that he was a little disappointed that in the PICL, "the issues were not too organized." He said that he felt that there was a great deal of time spent on issues that didn't concern all of the islands and that part of the group sat in disinterest for a good deal of the time since the issues being discussed didn't apply to their own jurisdictions.

Donor countries such as China scheduled a meeting with some of the leaders of PICL. One PICL representative said that probably due to political instability in the Solomons, Cook Islands, and Fiji, high leaders of other large countries were selected to represent each of the troubled islands at the meeting. The leaders of those islands perhaps understandably took offense at their lack of representation and expressed their concerns to PICL. The Solomons had Australia appointed as their representative which, according to the PICL source, particularly galled the leadership there perhaps due to RAMSI issues there.

The members of PICL were scheduled to have a briefing on the outcome of the meeting but most members boycotted that briefing in protest.

The members of PICL had high level meetings on Capitol Hill, facilitated by Congressman Eni F.H. Faleomavaega, representative of American Samoa. Leaders discussed many issues with Congress Representatives including fisheries resources and the possibilities of developing canneries within the Pacific instead of having foreign interests exporting all of the tuna from the Exclusive Economic Zones of the Pacific Island nations.

President Remengesau, of Palau urged Island leaders to commit to the Micronesia Challenge, a plan that has taken island nations across the world by storm. The plan calls for nations to protect 30% of their near coastal waters and 20% of their terrestrial (land) resources.

Issues visited by the PICL are likely to be taken up by the Pacific Island Forum if history is any example. That body does produce resolutions that have built in enforcements.

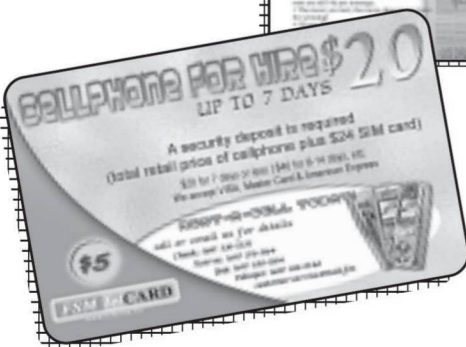

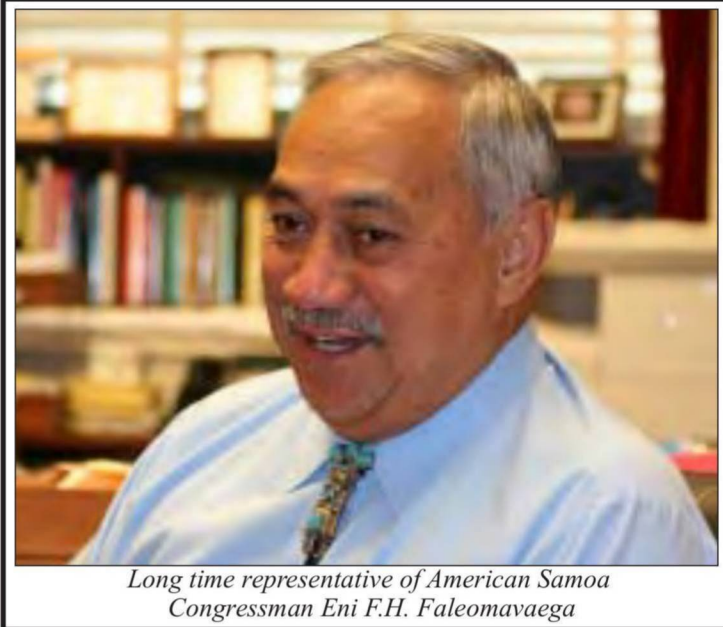
munication in the area said that they would be active in bringing speakers to the islands and called upon the leaders to let her know what subjects they could use help on. She wants also, to establish digital video conferences throughout the area. She also said that more visits by high level leaders of the U.S. would be made to Pacific areas.

Secretary Kempthorne said that the U.S. relationship with the Pacific is "something we take very seriously... We [in the U.S.] can barely comprehend the journeys made by early navigators a thousand years before Erik the Red or Christopher Columbus." He said that the Pacific Islands are situated near

some of the most geopolitical hot spots on earth and thanked the many people of the Freely Associated States for their service and sacrifice in the military.

He came along side Ambassador Hughes' earlier message to the leaders when he told the large gathered crowd that he would conduct a tour of many of the Pacific Islands in June. His trip will include visits to Midway Island, Guam, American Samoa, the Northern Marianas, as well as the Freely Associated States, which includes Palau, the Marshall Islands, and the Federated States of Micronesia.

He additionally announced that the Interior's Office of Insular Affairs will host the fourth Conference on Business Oppor-

tunities in the Islands on Guam on October 8 and 9, 2007. According to a press release, the conferences provide an opportunity for U.S. business people to meet with entrepreneurs and business owners and managers from the U.S. affiliated islands and explore ways of working together that will strengthen the economies of the islands.

"This is a magnificent gathering! You represent a significant, magnificent part of the world," he said in closing.

Long time representative of American Samoa Congressman Eni F.H. Faleomavaega who ended up with the microphone for a good deal of the evening as the leaders waited for a visit by Speaker Pelosi said in his inimitable style what he has been saying for years. "The Government of the United States has not been paying enough attention to

the Pacific Islands; Asia, yes, but not the Pacific."

Hawaiian Senator Daniel Kahikina Akaka who has been one of Hawaii's Senator's since 1990 paid a visit to the Pacific leaders to give his greetings.

Fijian dancers living in Utah performed for the group.

House Speaker Nancy Pelosi showed up after considerable vamping by Congressman Eni as he is popularly known. Congresswoman Pelosi, the first female Speaker is the representative of the 8<sup>th</sup> District of California. She said that Californian know all about their connection with the Pacific Rim though there were no representative from those countries at the gathering. She said in closing that "we think looking to the Pacific is looking to the future."

important meeting. I hope that today's events will give us an opportunity to broaden and deepen our friendships as we work together to build a bright, more democratic, and more prosperous future for all of our citizens."

President Kessai H. Note, President of the Republic of the Marshall Islands and the Chairman of the PICL had the onerous task of following Secretary Rice with his opening remarks. He said, "When former President George H.W. Bush in 1990 held his historic Pacific Island Nation Summit at the East-West Center, he emphasized that America views the Pacific not as a great ocean of

small islands and tiny populations, but rather, as an 'Aquatic Continent', the world's largest, covering a full third of the Earth's surface...with each island, like a string of pearls, possessing something unique to contribute to the value of the whole."

President Note said that he hoped the outcome of the PICL meetings would "expand and strengthen mutually beneficial linkages in terms of working together on practical approaches to advancing a number of issues."

He mentioned many of those issues including and invigorated JCC process, security in its broader sense including social, environmental, and economic

challenges. He hopes that one end result would be more US developmental assistance including US AID, MCA and expansion of the Peace Corps program.

He spoke of climate change and the problems associated with it that weighs heavily on the minds of all islanders. He quoted a recent study by the International Protocol on Climate Change that said that "sea level rise is no longer a matter of conjecture, but a reality."

Note in closing addressed Secretary Rice, "Madame Secretary, we trust and pray that through your good efforts, and the continuing attention we have from the East-West Center, the wellspring of goodwill can grow.

## Pacific Aquaculture Experts Team Up With Asian Counterparts

*SPC Media Release*

SPC Headquarters – Aquaculture is a young and promising industry in the Pacific region. To advance its progress, SPC (Secretariat of the Pacific Community) and Pacific aquaculture experts decided to team up with their Asian counterparts, NACA (Network of Aquaculture Centers in Asia-Pacific) for new training and research opportunities.

Seven participants from various fisheries departments in the region and private sector operations – from Papua New Guinea, Fiji Islands, New Caledonia and French Polynesia – will begin a three-week course on operating a marine finfish hatchery (with an emphasis on grouper species) in Thailand next week.

‘Outsourcing our training to Asia is quite a new thing for SPC, but interesting in that it shows the value of links to this region,’ says Ben Ponia, SPC Aquaculture Adviser. ‘The marine fish farming sector is one of the most dynamic in Asia. The training will enable our people to take stock of the successes of Asian operations, which are similar to theirs if you compare the level of technology used or the environmental constraints they have to deal with.’

World aquaculture production of groupers (FAO data) is around 6,000–7,000 tonnes per annum, valued at about USD 60 million. The bulk of this production comes from wild seed stock. Hatchery production of groupers is still low and irregular – they are difficult to rear because of their specific feed and environmental requirements. Developing skills in marine hatchery operation in the Pacific region is a new but promising venture, given the growing interest and demand for fish on local and international markets.

SPC’s aquaculture and fisheries training sections are working in collaboration with NACA (<http://www.enaca.org/>) and Thailand’s Department of Fisheries.

‘We hope that next week’s course will be the first of many. The training is the first step towards consolidating the aquaculture industry in the Pacific and offering new skills to our Pacific Island countries and territories,’ says Ben Ponia.

of trained personnel to implement approved FGR programs.

The FAO Panel of Experts on FGR on its 14th Session held early this year in Rome, Italy, has recommended a stronger action to support the management of forest genetic resources to achieve sustainable forest development and the current updating of the State of the World’s Forest Genetic Resources should further clarify the contribution of forest genetic resources to the achievement of MDG 1 (to reduce extreme poverty and hunger) and MDG 7 (to ensure environmental sustainability).

Enhance regional cooperation offers an effective solution towards a successful program on forest genetic resource conservation and management in the Pacific. Given the small size and limited resources of many Pacific countries, it is vital that a regional approach is adopted, such that information and genetic resources can be readily exchanged among SPC member countries and territories.

The objectives of the workshop are to:

- Develop a Pacific Island Regional Research and Development Agenda and an Action Plan for improved governance in the conservation, management and sustainable utilization of forest genetic resources, including a plan of follow-up activities after the Workshop.

- Strengthen and explore opportunities for collaboration amongst PICTs, other international and regional organisations and donor agencies with emphasis on forest genetic resources conservation and management and its application to poverty alleviation, rural development and climate change, within a community forestry framework.

The first two days of the work-

shop will be set aside for presentations of country reports, agency reports, technical presentations and discussions

The third day of the workshop shall be set aside for the preparation of the Action Plan for improved governance in research and development on the conservation and sustainable use of forest genetic resources within a community forestry framework.

The fourth day will be set aside for discussions on relevant issues to Pacific Forestry such as impact of climate change, logging code of practice, forest certification, biofuels and carbon offsets, invasive species and maximizing role of Pacific forests and trees to the well-being of the Pacific Islanders.

The fifth day will be a field visit to Fiji Pine plantation areas and the Fiji Forestry Department Sandalwood seed stand planting near Lololo.

Participants will be from the 22 Pacific Island Countries and Territories, international and regional governmental organizations, non-government organizations, civic, youth and gender-based organizations and academic institutions.

Main target group will be technical officers of the respective forestry agencies who are currently involved in forest genetic resources conservation and management, research and development, and extension works in their countries and territories.

The workshop will be organized by the Forests and Trees Programme, Land Resources Division of the Secretariat of the Pacific Community (SPC) in partnership with ENSIS (formerly CSIRO Forestry and Forest Products) and with co-funding support from the Australian Government (AusAID through its Pacific Governance Support Program).

### Kosrae Mayor Lost at Sea

MALEM, Kosrae – Families, friends and the people of Malem Municipality have mourned since March 30, 2007, when they believed their mayor disappeared at sea.

At about 1:00 p.m. on that stormy afternoon, Mayor Moses Lucias Charley took off from the Utwe boat marina hoping for his usual good catch. His wife, Jocelyn, who was the last person he spoke with, watched him as he headed off from the boat marina by himself. That was the last time anyone saw or heard from him.

The Local Disaster Office on the same evening that Mayor Charley was pronounced missing, was tasked to coordinate search and rescue operation in collaboration with family members, citizens, scuba divers, local and state government for a period of more than 2 weeks. Personal belongings were also recovered during the 2 weeks search and confirmed by family members as items from his boat: 2 fuel tanks, 1 white ice-chest, fishing line rolls, motor engine key, a short pants and a hat he was last seen wearing when he headed off from the Utwe boat marina.

Scuba dive operators went deep into a depth of approximately 160 feet within Utwe reefs where his personal items were located. More than 10 private boat operators also volunteered for the water search within a spread distance of around 26 miles far from the coastal area. *Sinlaku*, a state government boat and Micronesia Petroleum Corporation's boat, were also called in to assist during the operation.

The shocking disappearance of Mayor Charley set off the Utwe boat marina into a major congestion by volunteers from around every corner, from small kids to older folks who were also well provided for with drinks and food provided by the people of Utwe and families, as they sat and watched each boat return from their search rounds providing information update to the families. The search and rescue operation was coordinated through the state government under the direction of Mr. Henry H. Shrew, as the Incident Commander, given his capacity as Local Disaster Officer and supported by the Kosrae Public Safety Chief of Police and State Marine Surveillance and other key players.

Communications regarding the lost were also sent to neighboring fishing companies in Pohnpei. Companies such as the National Fisheries Corporation (NFC), Caroline Fishing Corporation,

Clear Water Incorporation (Long Liner), Micronesia Longline Fishing Company Inc and Luen Thai Fishing Venture, requesting support with an unveiling hope that they would somehow encounter any sightings.

It has been more than forty days from the date of his disappearance but the families are still in great disbelief and desperation to see the man they used to call a husband, father, brother, uncle and mayor.

Mayor Moses Lucias Charley before inaugurated some three (3) months ago as the mayor of the Malem Municipal Government was also in an acting capacity for about six (6) months as a mayor when his predecessor resigned. He was born on February 16, 1956 and is survived by his wife Jocelyn Moses Charley and their 2 sons and 2 daughters.

The Chairman of the Council, Mr. Alokoa L Talley through executive MOU automatically became the Acting Mayor. Mr Talley also indicated that his council members had reconvened through special session and passed resolution relating to his acting term. Acting Mayor Talley also stated that as much as he wants a normal operation on his municipal government there are certain legal procedures that have to be followed if a reelection will prevail.

Acting Mayor Talley and the families were also pleased on the logistic side where all different types of supports were provided by every individuals, including the youngsters in Malem and Utwe who had also donated much of their time to assist on the shoreline search. Special recognition and appreciation goes to the people of Utwe and their local government for the heartfelt thoughts and contribution of necessities and food to support the family as well as the volunteers.

The family and the office of Malem Mayor also extend their utmost appreciation to the following organizations and individuals who had also provided their invaluable support: Kosrae State Government; all participating branches and agencies; Municipal Governments (Utwe, Tafunsak, Lelu & Malem); US Coast Guard; FSM Congress Delegation Office; Kosrae Village Resort; Kosrae Nautilus Resort; Pacific Treelodge; FSM Telecommunication Kosrae; Micronesia Petroleum Corporation; Kosrae Broadcast Authorities; Congregational Churches; Municipal section groups (Otta); Families and Friends; Utwe Boat Marina (Norlin and Mary Livaie); People of Kosrae; All contacted fishing companies.

**NEWS****Urusemal Signs Final Measures From 14th Congress***FSM Information Services*

PALIKIR, Pohnpei – President Joseph J. Urusemal has signed into law the seven final legislations as adopted by the 14<sup>th</sup> Congress of the Federated States of Micronesia reports the FSM Information Service.

**PL.14-104:** amends the budget laws (PL. 14-95 & 14-99) to appropriate the \$2,418,036 for supplement the FY-2007 budget. While **PL No. 14-105** through **PL No. 14-109**, were amendments to previous laws funding various public projects in the four states. In his transmittal letters, the President had noted his concerns over the disparities between the figures from Congress and those from the Department of Finance and Administration (F&A). He therefore advised Congress that the Department will “certify and pay only the amount available in each project account.”

**PL.14-110:** amends Title 54 (Taxation and Customs) of the FSM Code as it relates to: expanding the tax payers subject to the corporate income tax regime, re-

defining paid-in-capital or equity of corporations, and insertion of a provision requiring submission of certain audited financial statements.

Along with the newly signed Laws were fifteen Resolutions as adopted by the Sixth Special Session of the 14th FSM Congress and the 1 day Seventh Special Session:

**C.R. No. 14-89** Calling on the President of the Federated States of Micronesia to establish a Special Task Force on accelerated Sea-Level Rise.

**C.R. No. 14-112** Expressing concern over the torment and cruelty appearing in broadcast images of recent executions carried out in the State of Iraq and calling upon the Nations of the world to eliminate abuse and torment in carrying out executions.

**C.R. No. 14-115** The Federated States of Micronesia’s accession to the revised constitution of the Asia-Pacific Telecommunity.

**C.R. No. 14-116** Confirming the nomination of Garrison Jovan Irons to be a member of the Fed-

erated States of Micronesia Social Security Board

**C.R. No. 14-117** Recognizing the continuing accomplishments of Mr. Manuel Miningfel of the State of Yap for his continued accomplishments and success in the international sport of weightlifting.

**C.R. No. 14-118** To approve a technical assistance grant from the U.S. Department of the Interior to provide fund to implement the “FSM Machine Readable Passports” modernization project.

**C.R. No. 14-120** Setting the ceiling of the National Funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2007.

**C.R. No. 14-121** Expressing the sadness and condolences of the Fourteenth Congress of the Federated States of Micronesia at the passing of the Honorable Johnny Reklai, President of the Senate of the Republic of Palau.

**C.R. No. 14-122** Expressing the sadness and condolences of the Fourteenth Congress of the Federated States of Micronesia at the passing of Chief Andrew B. Ruepong of the State of Yap.

**C.R. No. 14-123** To approve a grant from the United States Centers for Disease Control (CDC) for implementation of a comprehensive cancer control program for

the Federated States of Micronesia and each of the FSM States.

**C.R. No. 14-124** Calling on the President and the FSM Public Auditor to initiate and audit of the use of compact funds by the State of Kosrae.

**C.R. No. 14-125** Expressing the sadness and condolences of the Fourteenth Congress of the Federated States of Micronesia at the passing of the former President of the Federated States of Micronesia, His Excellency, Tosiwo Nakayama.

**C.R. No. 14-126** Expressing the gratitude of the People of the Federated States of Micronesia to the Honorable Peter M. Christian for his many years of dedicated service as a member and Speaker of the Congress of the Federated States of Micronesia.

**C.R. No. 14-127** Expressing the gratitude of the People of the Federated States of Micronesia to the Honorable Claude H. Phillip for his many years of dedicated service as a member and Vice Speaker of the Congress of the Federated States of Micronesia.

## USDA Assists Expanding Family by Providing Expanded Housing

PALAU - Benjamin Mengloi had lived in a two bedroom tin home for 40 years. Over that great span of time, the Mengloi family blossomed with children and grandchildren. Those 'flowers' have now all flourished into a grand, happy bouquet of 11 people. The expanding Mengloi family faced a dilemma all too common in big families. The home became overcrowded and unsafe. And, to make the situation even more discouraging, their income was not sufficient to enable the family to build a larger home.

Benjamin Mengloi had desperately sought financing with local banks in hopes of building a new home, but was repeatedly denied a loan as the family's income was not sufficient to qualify for a conventional mortgage loan.

After talking with a friend about Rural Development's 502 home loan program, Mr. Mengloi applied for a home construction loan. Much to the family's relief, Mr. Mengloi qualified for a mortgage loan with Rural Development, due to the program's generous 33-year repayment term and payment assistance program. This

lowered the required monthly payment to one that fit within Mr. Mengloi's budget.

According to Lorraine P. Shin, USDA Rural Development Hawaii State Director, "The delivery of our housing programs in the Western Pacific is consistent with USDA Rural Development's commitment to providing safe, well-built, affordable homes for low-income persons in rural communities."

In Mr. Mengloi's case, Rural Development approved and financed a \$70,500 Direct 502 Home Loan, with no down payment and minimal closing costs. This allowed the Mengloi family to construct a new, concrete home, consisting of four much-needed bedrooms and two incredibly-needed bathrooms. Mr. Mengloi expressed his gratitude by saying, "applying with Rural Development was the best thing I ever did. Now my family has a beautiful home that fits all of our needs." The expansion of Mr. Mengloi's budding family to nearly one dozen people is now equaled by their sizeable new house, where they are delightfully comfortable and safe.

**OPINION****Guest Perspective****RESPONSE TO ARTICLE ON PROPOSED BILL TO WAIVE PAYMENTS ON COMMERCIAL LEASES****Senator Marvin Yamaguchi's Perspective on L.B. No. 395-06**

On May 2, 2007, the Kaselehlia Press ran a story about L.B. No. 395-06, which waives lease payments on commercial leases. While Kaselehlia Press was unable to talk to me about this bill prior to running the story, the paper was kind enough to allow me to present my perspective on the issue so the people of Pohnpei have a clearer picture of the bill.

Unfortunately, there is an important piece of misinformation in the article. This misinformation is the statement attributed to the Director of the Department of Treasury and Administration that outstanding lease payments due have dropped from over \$4 million to just over \$2 million. I have spoken with the Director about this subject, and he told me that over the past four years collections have been less than \$100,000. For example, in the Governor's proposed budget for Fiscal Year 2008, the total amount expected to be available for appropriation from the Public Lands Trust Fund is \$138,547. This includes money left over from previous years, as no money was appropriated from this fund in FY '06 and only \$37,040 was appropriated in FY '07. The Governor's current budget estimates that in Fiscal Years '09 and '10 only \$38,864 will be available for appropriation from the Public Lands Trust Fund each year. This figure of less than \$40,000 includes both commercial and residential lease payments. Because people need to pay their residential leases in order to get a leasehold conveyance certificate of title, the real pressure to collect comes on the residential side and not the commercial side. Despite Pohnpei's abundant public lands, public lands leases, and commercial leases in particular, have never generated significant income for Pohnpei State.

A second problem has to do with the unfair rental rates that are being used for commercial leases. Commercial leases are being issued with very different rates per square meter. For example, while some leases are only fifteen cents, other leases cost two dollars. Just recently, five very valuable fifty-five year development leases were made by the Board of Trustees of the Pohnpei Public Lands Trust for properties located on the Dekehtik Causeway. These leases are completely rent free. There is no money at all for the government or the people of Pohnpei, only a requirement that the areas be developed. After those leases were issued, the Legislature passed a law prohibiting further leases on the Causeway until a comprehensive development plan could be enacted and requiring the Attorney General's Office to investigate the legality of these free leases.

While distinguishing between commercial and residential leases once made sense, this

is now an outdated concept. Residential leaseholders who get their certificate of title might eventually convert the land to commercial purposes. This is unfair for commercial leaseholders, who cannot get a certificate of title and who are not supposed to convert their land to residential use. If a residential leaseholder builds a small store on their residential lease before getting a certificate of title,



this lease is automatically converted to a commercial lease. None of this makes any sense. Under a modern land system, land users should be free to use their land however they want. The interest of the public should be protected through zoning and planning, not through public lands leases.

It is clear that the old system for leasing public lands is not working. Public lands are not generating any significant local revenues and the way leases are issued is unfair. L.B. No. 395-06 is not a permanent solution, it is only a temporary stop-gap until our public lands system can be brought into the Twenty-First Century. With the help of the Asian Development Bank, Pohnpei State is reviewing its system of public lands administration and management. Part of that project is to develop a fair land valuation system that will be enacted into law by the Pohnpei Legislature. Such a valuation system will ensure that all land transactions provide fair compensation for everybody, and will provide the foundation for new land policies in Pohnpei.

It is my hope that our future land policies will move towards greater privatization of public lands. Our homesteading program, which has been in operation for many years in Pohnpei, was a program that converted public lands to private ownership. The Public Trust Lands Residential Leasehold Conveyance Act of 1999 continued this process by allowing the holders of residential leases to get a certificate of title for their land. The certificate of title is important because it encourages people to invest in their land. Nobody wants to spend money to improve some-

body else's land. But if you own your own land, you will work hard to make your land better. Banks also want a person to have a certificate of title before lending money for development purposes. I support this process of assisting Pohnpeians in getting a certificate of title, which is why Senator Fernando Scaliem and I introduced L.B. No. 332-06, which would allow holders of residential leases to get their certificate of title without having to make their lease payments.

The same concept that applies to residential leases applies to commercial leases. If Pohnpeians own their own commercial properties, they will work harder to build up their businesses. It will be easier for them to get bank loans or other financing to invest in new building projects. As I pointed out before, the Public Lands Trust does not generate significant revenues for Pohnpei State. On the other hand, our sales tax and revenue sharing from national taxes provide almost all of our local revenues, and these taxes rely on having a strong business community. Pohnpei State expects to receive about \$6.915 million in taxes next year (both state and national). These tax revenues are generated by economic activity in Pohnpei. A stronger economy means greater tax revenues for Pohnpei State. The current strategic plan in the FSM is to replace import and sales taxes with a value added tax. Similar to the sales tax, the value added tax relies on business transactions to generate revenue. Thus, if our land policies assist Pohnpeian businesses to grow and become strong, the additional tax revenues for Pohnpei State will far outweigh the insignificant lease payments we are currently collecting. In the long run, it is a strong private sector economy that will ensure the financial independence of Pohnpei State, not public lands leases. L.B. No. 395-06 will contribute to a stronger business climate in Pohnpei.

I want to stress that my vision for the future of public lands is not to assist big business owners in Pohnpei. Small businesses are the backbone of our private sector, and they provide the talent and innovation needed for Pohnpei to compete in the global economy. Instead of the current leasing system that lacks transparency and accountability, I hope we can put a fair and transparent system into place that will allow all Pohnpeians to get certificates of title for commercial properties. However, to replace the current system will take time and will require us to change the way we think about land. It is also critical that we put the land valuation system into place before we further open up our land policies. But until we can do that, we at least have to put a stop to the current unfair policies.

The truth is, Pohnpei State makes very little money from residential or commercial leases of public lands. L.B. No. 395-06 will cost Pohnpei very little, but will put a stop to the current unfair lease rate system.

By the time you read this column, one of these four senators-elect would have been SELECTED by his peers to serve as the 7<sup>th</sup> President of the FSM, namely—Alik Alik of Kosrae State, Joseph Urusemal of Yap State, Manny Mori of Chuuk State and, Resio Moses of Pohnpei State.

In hindsight, it is worth nothing that Kosrae State missed serving a full 4-year term because former President Jacob Nena, who served out the remaining two years of President Olter's second term, was not around to receive the presidency. As everyone recalls, former President Bailey Olter of Pohnpei State died during the 6<sup>th</sup> year of his administration and Vice President Jacob Nena became President Jacob Nena for 2 years only.

Kosrae State's record of the presidency could have been better had President Nena kept his at-large seat in the subsequent election but he lost to Alik Alik, a new comer and the FSM Congress, in its 28-year history, has not broken its tradition of reserving the two top posts for the more senior and seasoned members. But now Senator-elect Alik Alik has built up the seniority and credentials that are attractive for the top executive post, including several years in the diplomatic circle and two full terms as Kosrae's At Large Senator to the FSM Congress. Kosrae State knows something you and I don't know—they are gearing up for a vacant seat in Congress.

Many observers feel that had the Chuuk Delegation been united in the past 8 years, Redley Killion would have been the President instead of Falcam. Four years later, the alleged disunity in the Chuuk Delegation cost them the Presidency again. Killion was the likely Presidential candidate but Congress gave the post, instead, to Joseph Urusemal of Yap. And now Killion lost to Manny Mori whom many observers believe is a strong contender for the top post.

There were observations that Chuuk would argue that it is time Chuuk takes the Presidency again after Tosiwo Nakayama got it first some 26 years earlier. I keep hearing the sentiment that this time the Chuuk delegation is unified and all they have to do is offer two posts to any of the 3 states and put their at large member, Manny Mori, into the president's seat.

It is rare in our history to unseat a sitting President and send him back to the Legislative Chamber to conduct business as just another senator. Congress gave former President Tosiwo Nakayama two terms. But former President John Haglelgam of Yap got only one term because he lost the subsequent election that would have or could have given him a second term.

Former President Bailey Olter was given two full terms only to die in the middle of his second term and, as stated earlier, former President Jacob Nena lost the election that would have/could have catapulted him to a full 4-year term.

And as history would seem to repeat itself, former President Leo Falcam got only one term because he lost the election that would have/could have given him a second term.

Unseating a sitting President is rare and, in my opinion, is a demotion that would make the FSM look bad in the eyes of the international community. The State of Yap recognizes this and is the only State Legislature to pass a resolution asking the 14<sup>th</sup> Congress to allow Senator-elect Urusemal to continue his second term. But there is the question: What will Yap do if Congress refuses? Remember the murmurs of Yap joining Palau?

In 1987, the Pohnpei Traditional Leaders banded behind freshman senator Leo Falcam in attempting to force the FSM Congress to give Pohnpei the Presidency. Congress did not budge and gave it to Yap's John Haglelgam instead. That action incited continued talk of secession but that's it, just talk.

That leaves Senator-elect Resio Moses, who has served the At Large seat for a couple of terms. Contrary to media reports that "he will not seek the Presidency," Moses never said so, at least publicly. Senator-elect Resio Moses has the most executive experience among the four at-large candidates and so if his colleagues were to base their selection criteria on executive experience, Resio Moses would be the most qualified.

The interesting thing is that, other than the near landslide vote in his favor, there's no official Pohnpei State support for him to become the next President. Do the Leaders know something we don't???

**ENVIRONMENT****Environment: FUTURE LEADERS SPEARHEAD CHANGE**By **ASTERIO TAKESY**

For generations, Pacific islanders have carved their traditions, culture and living from the natural resources of land and sea. The Pacific way, our island life, is built on a foundation of respect for the environment and the natural systems that sustain our livelihoods.

Within the current global climate of change, there is an urgent need to work with communities to learn to adapt the onset of changes in order to protect Pacific history, culture and traditions.

Throughout the region, considerable resources are invested in areas that will help communities and governments prepare for change. There is a critical urgency to invest in people—to build the social capital of the Pacific islands; to ensure that the future leaders are equipped with the skills, knowledge, outlook and commitment to use the limited natural resources with the least impact on the fabric of Pacific identity.

To help them make decisions that meet the needs of the present, without compromising the needs of the future, and with respect for the past. That's what this article is about. From April 2-4, SPREP and UNEP brought together more than 30 young people: current and aspiring professionals, working or

studying in the environment field, to attend the Pacific Future Environment Leaders Forum in Apia, Samoa.

Representing 14 Pacific countries and territories, the Forum explored the notions of global and regional leadership, whilst providing sessions in practical skills pivotal to strong environmental management including project management, proposal writing, and negotiation skills. The participants included a large contingent of students from USP in Suva, who came with smiles, a guitar, energy and a desire to learn and share their knowledge and experiences.

While there are many philosophical discussions on what constitutes a 'good' leader, there is common agreement about what comprises leadership. Some key statements at the meeting: "We can say that leadership is courage and spirit. Leadership is about growing people. Leadership is about getting the job done. Leadership is about knowing the issues. Leadership is about looking to the future and having a vision."

The Forum allowed the young people to look forward to the future, to envision the impact of issues such as climate change. In one of the sessions, the participants learnt about the effects of climate change on their commu-

nities, such as drought, sea level rise, effects on agriculture and biodiversity loss. Within these scenarios, the participants then developed possible community-based adaptation measures.

The ideas, vision and creativity that emerged from this session highlighted the incredible talent of this region's future leaders. Not only did the young people identify similar adaptive measures highlighted through extensive national consultations, they approached the task with passion, commitment and teamwork, and an overarching ethos that "where there's a will, there's a way."

This Youth Forum was the first regional capacity building workshop, facilitated by SPREP, which was aimed directly at young people promoting environmental sustainability in the region. The Forum is part of an ongoing programme for future leaders in the environment sector as part of SPREP's commitment to build capacity of Pacific islanders for strengthening environmental management. The Forum complemented the work undertaken by the Secretariat of the Pacific Community (SPC), to support young people in the region; it was a privilege to have the presence and participation of a key SPC represen-

tatives throughout.

Samoa's Ministry of Natural Resources and Environment provided support in an ongoing partnership with SPREP. Amidst the uncertainty of the future, there is a growing recognition of the critical need for strong voices from the region. Voices that will share with the rest of the world the needs, the complexities, and the right solutions for the more than 8 million people living in the Pacific. Voices that will take the messages from the people of the vast Pacific islands region to a global platform.

The forum provided an opportunity to strengthen the Pacific Youth Environmental Network (PYEN), established by UNEP to act as a vehicle to unite the growing numbers of young Pacific Islanders who are concerned about protecting the Pacific environment. The challenge now for young people is to embody the change they wish to see in this region: to have the courage to embrace the principles, spirit and integrity to continue to strive for the change that needs to happen in the Pacific; to become the Pacific's future environment leaders; and to ensure that the beauty, uniqueness and diversity of the Pacific islands are protected for future generations.

**International Conservation Organizations Applaud Global Environment Facility's \$100 Million Proposal****\$100 Million Proposed to Protect Island Biodiversity; Six million for Micronesia Challenge***The Nature Conservancy*

**Washington, D.C. (May 9, 2007)** – Conservation International (CI) and The Nature Conservancy applaud the Global Environment Facility (GEF) proposal to increase funding to help Pacific Island nations cope with climate change and promote sustainable development through conservation and sound natural resource management.

Part of that proposal is \$6 million directed for the Micronesia Challenge, a landmark conservation initiative in the Northern Pacific to effectively conserve 30 percent of marine resources and 20 percent of terrestrial resources by 2020.

In a meeting with three Micronesian leaders, the GEF proposed committing \$6 million in funds, match \$6 million pledged jointly to The Nature Conservancy and Conservation International, to provide long-term funding for the Micronesian Challenge. The leaders and their partners are

working to secure a total of \$18 million for sustainable financing for the first phase of the Challenge.

During this week's meeting with GEF, President Remengesau from Palau, President Note from the Republic of the Marshall Islands (RMI) and Vice President Killion from the Federated States of Micronesia (FSM) together highlighted the importance of the Micronesia Challenge in ensuring both sustainable development for their countries and the preservation of traditional cultures. The leaders were in Washington DC for the Pacific Island Conference of Leaders.

"The GEF's proposed \$100 million commitment to island conservations send a clear message to the rest of the world that large-scale conservation is critical and will be supported but the international community," said Steve McCormick, president and CEO of The Nature Conservancy. "The proposed funding for the Micronesia Challenge and the re-

markable leadership demonstrated by these governments will help ensure that these unique islands and their rich reefs and other ecosystems are protected, allowing the people who inhabit this 'continent' of tiny islands and atolls to continue to live in harmony with nature as they have for countless generations."

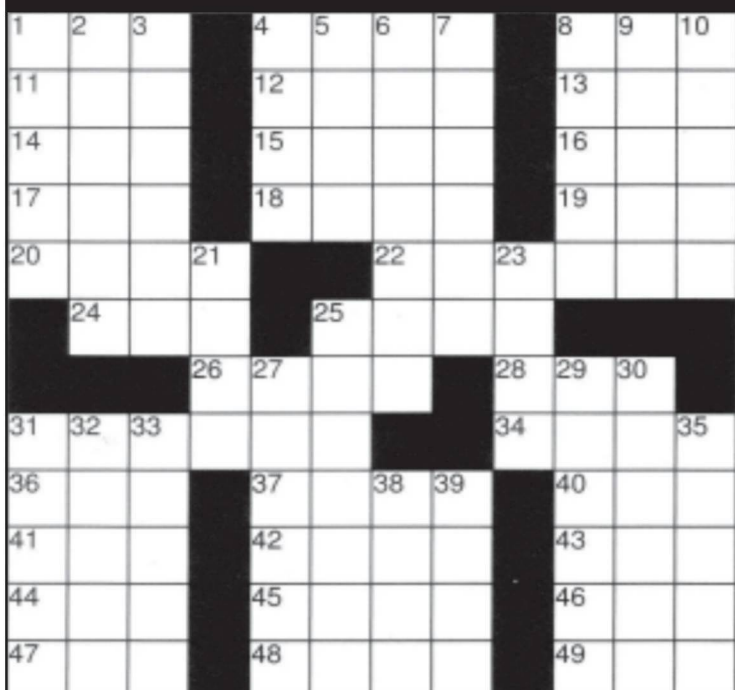
"We commend Monique Barbut, the GEF chief executive officer and chairperson, for this decisive step to protect such unique and crucial biodiversity," said Per Seligmann, the chairman and CEO of Conservation International. "This proposal demonstrates the full engagement of the GEF in supporting the visionary leadership in Micronesia and understanding the connectivity between human well-being, biodiversity and climate change."

The Micronesia Challenge is a collaborative conservation effort of these three island governments with two U.S. jurisdictions—the Territory of Guam and the Com-

monwealth of the Northern Mariana Islands—encompassing more than 6.7 million square kilometers (2.6 million square miles) of ocean. The Challenge will help protect at least 66 threatened species, four percent of the global total reef area and 58 percent of all known coral species. Micronesian waters are also home to the world's largest tuna fishery and more than 1300 species of reef fish, which are important island food sources.

Throughout Micronesia, the majority of people living on these small islands depend on natural resources for their food, livelihoods, traditional cultures and hopes for future long-term economic prosperity. According to President Remengesau, "The Micronesia Challenge is our effort to ensure a better life for our children and ensure that our cultural pasts will not be forgotten in light of the development challenges that we face today."

How is the Pacific going on the road to greater gender equality? How gender-sensitive are our regional organisations? What are the latest initiatives to combat violence against women?

Pacific media are invited to find out the answers to these questions and much more at the 10th Triennial Conference of Pacific Women (May 27-31, 2007) and the Third Pacific Ministers Meeting on Women (June 1). Both take place at SPC's headquarters in Noumea, New Caledonia.

HDP will be issuing regular press releases from an event that promises to be full of news.

The unifying slogan of the two meetings is Pacific Women, Pacific Plan: Stepping up the pace to 2010. The slogan refers to the blueprint for action agreed on by Pacific governments, the Revised

Pacific Platform for Action on Advancement of Women and Gender Equality 2005-2015. The year 2010 is a milestone when the international community will take stock of progress against the anti-poverty Millennium Development Goals, which link with the PPA.

The delegates, who number more than 130, include ministers for women, politicians, and those working in development, gender issues, and policy. From each of SPC's 22 Pacific member states, HDP invites the minister responsible for women, the head of the government department charged with gender issues, and one representative from a non-governmental organisation.

The programme includes practical workshops on subjects such as gender statistics; how to mainstream gender into national policy; and strategies for getting a Pacific representative onto the United Nations' CEDAW committee, the

international body that oversees progress on the Convention on the Elimination of All Forms of Discrimination Against Women.

Other sessions look at how to engage young women in leadership roles, reveal the results of the "gender stocktake" into 10 major regional organisations, and share results of a study into land tenure in the Republic of the Marshall Islands, Vanuatu and the Solomon

Islands.

**Gov. Anefal seeks help on impending Embargo****Department of Youth and Civic Affairs**

Colonia Yap – Continental Airlines has revealed its plans to place an embargo on all cargo as well as excess baggage on all flights out of Yap, starting from June 16, 2007. This decision has forced Yap State Government to seek the

urgent assistance from the FSM President and the National Government to appeal to the U.S. Authorities as soon as practicable. In his May 4, 2007 communication to the FSM President Joseph J. Urusemal, Governor

Anefal says that Continental's decision to impose such an embargo "will further negatively impact the local economy gravely to an unheard low." The embargo will affect all businesses that depend on airfreight services including the lucrative betel nut trade and will lead to loss of income for many citizens. Governor Anefal fears that the imposition of this embargo will certainly undermine and downgrade Yap's economic development efforts to unthinkable levels, which is contrary to the intent of the Compact treaty with the United States. Anefal believes that by "allowing another U.S. monopoly to single-handedly tear apart the very economic development effort negotiated in good faith under the Compact is a stinging slap in the face of the spirit enshrined therein."

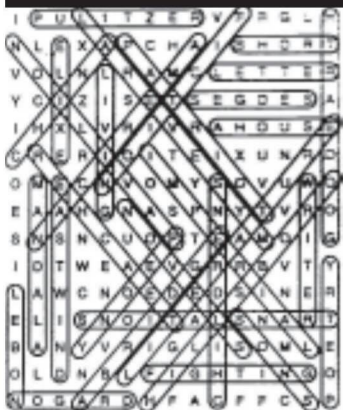

2,713.5 POUNDS WEIGHED IN AT PNI FISHING CLUB'S  
14<sup>TH</sup> ANNUAL TOURNAMENT

Alex Tretnoff, Jr. is continuing a family tradition of winning fishing tournaments. The young man landed 295 pounds of fish over the two-day 14<sup>th</sup> Annual Tournament, including a 180 pound marlin caught during the first day of fishing last Thursday, 10 May. Alex Jr's point total won him the first prize of two free airline tickets to any Continental Micronesia destination.

Placing second in the tournament, Noel Boylan proved that he can still catch the big ones by weighing in a 114.5 pound yellowfin tuna. This fish is the heaviest yellowfin caught in the fifteen year history of the Pohnpei Sighing Club, and surpasses Noel's own yellowfin record, 93.5 pounds, set in 1993. Noel also caught 52.5 and 48.5 pound yellow-fins during the tournament.

Kumer Panuelo captured third place in the 2007 AT with 154 pounds caught, including a 52 pound yellow fin, five good sized skipjack tunas, and one mahi mahi.

All ten boats registered for the contest brought fish to the weigh-

in at Rumor's Bar. In addition to Alex's and Noel's giants, there were a number of good size yellow fin, including a 55 pounder caught by Aminis David Jr., a 52 pounder caught by Johnny O'Keefe, a 51.5 pounder by Andy Musrasrik, and a 37 pounder landed by Iginio Walter.

The ladies side of the contest was dominated by Mersihpel Ioinis, who caught 86.5 pounds of skipjack and mahi mahi, while fishing in her very first P-F-Club tournament. Nannette Apis took second place Lady Angler honors with 37 pounds caught, and Maria Spegal garnered third place with 35 pounds total. All the lady anglers specialized in landing skipjack during the contest.

No junior anglers caught qualifying point fish during the contest, so prizes were awarded on the largest fish caught. Alex Kalau landed a 15 pound barracuda and Evan Boylan caught an 11 pound mahi mahi.

More than \$5,000 in prizes was given away at the Sunday evening Awards Presentation at PCR Restaurant on May 13<sup>th</sup>.

The top three boats were able to pull in more than 350 pounds. "Boat", captained by Alex Tretnoff took first place Total Boat Weight with 416.5 pounds. Second place went to *Tygris*, captained by Kumer Panuelo with 409.5 pounds. The third place position, 353.5 pounds, was won by a boat named *Miss Pakin*, captained by Andy Musrasrik.
