SPECIAL ASSISTANT FOR TRWP IN GUAM

Mr. Konto Sandbergen, formerly of the Political Affairs Staff, has joined the Liaison Office in Guam on a temporary assignment as "Special Assistant for the Trust Territory Rehabilitation Workers' Project." He will act as liaison between the Immigration Department, the various Contractors, LNO Office, and the workers. It is anticipated that this assignment will run for the next several months. Mr. Sandbergen had been reassigned to the Marshalls, but has been released by District Administrator, Marshalls, for the time being to work on the Guam Rehabilitation Project. Konto also recently acquired a wife, in addition to his new assignment, having been married on November 24, 1962, to the former Daisy Fleming of Tinian.

BEHOLD, HQ DRIVERS OF GOVERNMENT CARS

It has been repeatedly found that drivers of government vehicles do not properly secure the cars after use. Frequently, the car windows have been left opened and ignition switch unlocked. With the kind of weather we have here, it is particularly undesirable to leave the car windows open as the rain will get in the car, wet the seats, and ruin them. It costs the government a lot to replace them. The ignition switch, too, when left unlocked, may be dangerous and costly. Unlocked cars may be driven off without permission and may be involved in an accident, which will not only result in property damage but also personal injury.

HOTEL ACCOMMODATIONS ON GUAM

The facilities of the Trust Territory Hotel in Guam are taxed to capacity; people are being bunked on cots in buildings adjacent to the Hotel.

Until further notice, all travel to Guam requiring hotel accommodations must be cleared through the Executive Officer, in order that coordination of travel and hotel accommodations may be accomplished. The Executive Officer will then consult with the Liaison Officer in Guam to determine if the requests can be met.

PAN AM HOURS VIP DAY

A Governor, a Prime Minister, a Mayor, a Samoan Chief, plus 13 Presidents of major companies arrived in Sydney, Australia, aboard Pan American's Flight 811, at 7:35 a.m. on Tuesday, December 4, 1962.

This flight marked the inaugural of Pan American's South Pacific flight No. 811, via American Samoa.

The Governor? Governor Rex Lee of American Samoa. The Prime Minister was Mr. Mataafa of Western Samoa and the Mayor, Alderman Stinson of Suva, Fiji. The Presidents were all of major Hawaiian and American organizations, while the Samoan Chief was Mr. Leusto, Secretary of Samoan Affairs in American Samoa.

Also aboard the aircraft was Aggie Grey, world famous owner of "Aggie's" Hotel in Samoa.....of "South Pacific" fame.

An extensive sight-seeing program was arranged for the distinguished visitors. At 2:30 p.m. Tuesday, De-

cember 4, Governor Lee, Mayor Stinson and Prime Minister Mataafa paid an informal call on Sydney's Lord Mayor, Alderman Jensen. This was the occasion for a presentation from the Lord Mayor of Suva to the Lord Mayor of Sydney.

In the evening, the group attended theatrical performances.

The following day, Wednesday December 5, the group went on a full day's tour of the Hawkesbury River; in the evening a number of the group visited Chequers.

On Thursday, December 6, they boarded a Sydney ferry boat for a cruise around the Harbour, and returned at 12:30 p.m. The Sydney press were extended an open invitation to join the visitors on this occasion.

Later that afternoon, various members of the group boarded Pan American flight 812 leaving Mascot at 5:00 p.m. while other members continued to explore Sydney.
