2012 Western and Central Pacific Fisheries Commission Fishing competition

Saturday 25th of February saw the Pohnpei Fishing Club kick off the 2012 fishing calendar in style. Glenn Hurry from the Western and Central Pacific Fisheries Commission (Tuna Commission) rounded up some off-island support for the Tuna Commission Tournament. A generous prize pool of approximately \$4000 made up of cash prizes and fishing line and lures were donated by MRAG Asiapacific, Pacific Ocean Producers (POP), HALCO, TRIMARINE and the Parties the Nauru Agreement (PNA).

Such a large prize pool saw 22 boats enter chasing the generous prizes. Leading up to the tournament the weather had been ordinary at best with large swells and plenty of wind. The fishing Gods shone down on the fisherman during the tournament and made the conditions very fishable. The rain even held off until about 11:00am. There were a number of quality fish caught from all over Pohnpei and Ant Atoll. Three sailfish, wahoo, yellowfin and dog tooth tuna were all welcome catches. Mahi Mahi and skipjack were harder to come by with not many weighed in.

Despite the afternoon rain a great crowd turned up at Kumer's Dock to watch the weigh in. With a raffle, beers and bbq, and PFC t-shirts for sale the crowd was kept entertained as the boats lined up. The three sailfish were definitely crowd pleasers with their beautiful sails fully lit up and on display on the weigh-in dock. With prizes for the biggest fish, five different species, female and junior anglers and only one prize per fish there was a great chance that the prizes would be spread out among the competing club members. Nanpohnmal man stabbed in his home while sleeping

Nanpohnmal, Pohnpei—Sometime during last Sunday night Pidel Andon was stabbed inside his home while he lay sleeping on his couch. His wife, Lisa and two children were sleeping in another room at the time of the incident.

Police say that the report is that someone entered the victim's home and used one of their own kitchen knives to stab him. Their Public Information Officer said that the knife was found on the porch. They could not determine how the perpetrator entered the home in the middle of the night.

Mr. Andon is currently in the Pohnpei State Hospital for treatment of his wounds. At press time we could not get an answer regarding his condition.

The police department spokesperson was not able to say whether anything had been stolen from the home. He said only that he had not received any information from detectives about whether anything was missing from the home.

Police have not yet identified a suspect in the stabbing and have asked that anyone with any information on that night's violent crime to please call the Pohnpei State Police Detectives office at 320-3774.

Non-Project Grant Aid for provision of industrial products by the Government of Japan

Palikir, Pohnpei—A Note of Exchange was signed by Secretary Lorin S. Robert and Ambassador Eiichi Suzuki on behalf of their respective governments on February 22, 2012 in the afternoon. The signing of the Exchange Note signifies the agreement of both governments for the donation of an aggregate amount of Japanese Yen 250 million (around USD 3 Million) to the FSM for the procurement of industrial products and the acceptance of the latter of the products to be used for development purposes.

The donation from the Government of Japan is considered a Japan Non-Project Grant Assistance (JNPGA) which is the second time the FSM Government has benefited from this type of assistance. It has special historical significance in that the industrial products were produced in the Tohoku region of Japan which was devastated by the Great East Japan Earthquake and Tsunami, and the signing of the agreement made FSM the first recipient of such assistance. The Government of Japan, as a donor country, expressed its intention that the equipment procured should be used for shoreline protection and national building as a priority.

In accepting the donation, Secretary Robert thanked the Japanese Government through Ambassador Suzuki and expressed the pride of his government in being the first recipient of such manufactured items from the Tohoku region, which signals the speedy recovery of the affected areas from the devastation caused by the earthquake. He also reiterated the continued sympathies and condolences of the FSM government and people for the tragic loss of lives and extensive damage to property. Secretary Robert went on to say that as an island-nation, coastal problems are an on-going problems for the FSM and the FSM will welcome the heavy equipments for the infrastructure construction such as roads to mitigate the negative effects by the coastal erosion.

Ambassador Suzuki responded by conveying the pleasure of his government to make FSM the first recipient of such assistance and also reiterated thankfulness for the expression of heartfelt sympathies from friends like the FSM for the untold loss experienced by Japan in the wake of the natural disaster. He also indicated his hope that the manufactured goods will be used for coastal protection and nation-building.

Witnessing the short signing ceremony were staff from Foreign Affairs and the Embassy of Japan in Pohnpei.

Climate Change

Pohnpei received training on climate adaptation tools

The Micronesia Conservation Trust (MCT) and its Micronesia Challenge (MC) partners are excited to launch several new tools to support community based climate adaptation in Micronesia. These tools were developed through a collaborative process with community members, resource managers, conservation practitioners and climate change experts in Micronesia. They reflect local needs to overcome challenges faced in adapting to regional climate change conditions. MCT is now coordinating trainings on how to effectively use the toolkit in three of the MC Jurisdictions, Republic of Palau, Federated States of Micronesia and the Republic of the Marshall Islands.

From January 23rd to 27th the Micronesia Conservation Trust coordinated a training activity in Pohnpei introducing these new tools. The AusAid Small Grants Scheme and US Department of State, Environmental Small Grants program provided funding support. Staff from MCT, The Natural Conservancy and members of the Pacific Islands Managed and Protected Areas Community along with two independent consultants facilitated the training. Participants included representatives of and staff from the FSM National Government Department of Resources and Development, Pohnpei State Department of Land and Natural Resources, the Conservation Society of Pohnpei, International Organization for Migration, SPC/GTZ, Pohnpei State Forestry, Pohnpei Farmers Association, Micronesia Conservation Trust, The Nature Conservation, Community Conservation Officers, traditional leaders and PREL.



Using the communities of Dehpek in U, Metipw in Madolenihmw and Nanpil in Nett as examples, participants discussed in depth Climate Change (CC) concepts and practiced using the toolkit's flipchart and booklet components with the on-site community focus groups. Participants also developed a communications strategy, which included the best ways to communicate CC concepts to local communities in the Pohnpeian language. These discussions focused on how changes in weather patterns are affecting breadfruit and yam seasons and how this will have drastic effects on Pohnpeian livelihoods and traditional practices. Specifically, participants found that using the Pohnpei traditional calendar will help communities relate to the phenomenon of climate change. There are three main seasons in Pohnpei which includes Rekenleng- Breadfruit Season, when fish are also aggregating, spawning and in abundance, Rekenpwel – Yam Season and Isol-food, scarcity season, which is usually associated with the time between the end of the yam season and the breadfruit season. Pohnpeian communities learned how to survive year- in year- out by observing the seasons, weather patterns and adjusted their agricultural and cultural patterns and cycles accordingly. Communities have realized today that these seasons are changing, sometimes becoming shorter or longer, and coming earlier or later unpredictably. These changes in weather patterns will affect the already changing traditional seasons. Thus, such events could cause profound social and environmental impacts in Pohnpei. Pohnpei's communities should care about these changes because of their potential impacts on food security, culture, health and natural resources.

Following the training, participants formed the Climate Change Outreach Committee chaired by Mr. Valentine Martin-Dauk Sokehs. The committee has finalized its communication strategy and developed a plan to begin outreach in communities throughout Pohnpei. The first outreach activity will be held in Dehpehk and Takaieu communities and will be lead by Mr. Pedrus Primo-Kehlahk Takaieu, who participated in the training. The committee will proceed to other communities immediately following the outreach work in Dehpehk and Takaieu.

The Micronesia Conservation Trust (MCT) and its Micronesia Challenge (MC) partners would like to thank the Pohnpei State Governors Office for its generous support in providing the venue for the training. We look forward to strengthening our partnership with Pohnpei state government as we work together to improve Pohnpei's resilience adaptability to Climate Change.

Gas prices and transportation costs in the region continue to rise

FSM PetroCorp will need to raise wholesale costs to meet the challenge.

FSM Petroleum Corporation

Pohnpei, FSM—Due to a direct impact of international oil markets, fuel prices will increase in the FSM between 25cpg to 35cpg (cents per gallon).

This price increase is the first in seven months. While the increase appears large, it pales in comparison to price movements observed by our neighbors Guam, Saipan and Palau.

“We have retained our wholesale prices at levels that have allowed consumers access to fuel pump prices at around \$5.00 per gallon for over seven months. This is a massive achievement. Prices in Guam are now \$4.97 per gallon and you can't ask for more cushioning than that. The sharp increase of over 40 cents in two months is more than we can absorb, and we need

to change our sales prices over the next two weeks so we can pay for future fuel cargos” says Chief Executive Officer, Mr. Jared Morris.

Elsewhere in the region, Guam and Saipan have experienced volatility in pump prices, with Guam seeing an upward swing of over .80 cents since mid- January 2011. PetroCorp's relative price stability over that timeframe has also been highlighted when contrasted with fuel prices in the Republic of the Marshall Islands and the Commonwealth of the Northern Mariana Islands (Saipan, Rota and Tinian). Both the RMI and CNMI currently have pump prices as high as \$5.75 at some service stations.

Global oil prices are now over \$100 per barrel, the highest prices they have been since October 2008. At that time, the

FSM was hit hard with reports of gasoline reaching \$6.70 a gallon in some areas.

The wave of both actual and potential unrest and democratic change across the major oil-producing countries of the Middle East, including one of the world's largest oil producers, Saudi Arabia, have contributed to market prices increasing.

While oil production by the major oil-producing countries remains relatively steady, both the major developing economies of India and China, which are expected to have growth rates of 7.8 percent and 9.2 percent respectively in 2012, will continue to increase the demand for oil, and has the potential for step increases in price globally.

Recent EU and US sanctions against Iran, another oil-producing country, may also

cause global prices to trend upward in 2012, as that country has threatened to cut exports to certain western countries, and boasted of soaring the cost of oil per barrel by 50%.

“While oil prices have clearly moved around 40 cents per gallon, we are only increasing our prices around 30 cents. We are hopeful that markets will cool over the next month, but if they don't, we are left with no choice but to match these movements” says Chief Executive Officer, Mr. Jared Morris.

FSM PetroCorp will be monitoring developments closely and utilizing the tools and capacity it has available to maintain consistency and affordability to its customers and the public at-large as best it can over the next 12 months.

Yap celebrates 44th Annual Yap Day Celebrations

The first two days of March 2012 marked the 44th annual Yap Day. Yap Day celebration took on a unique turn this year as it was held in Colonia, and for the first time the Yap Living History Museum also located in Colonia served as the central venue for Yap Day.

This two-day event brought in people from around the island, guests from neighboring island nations, and visitors from around the world.

Like in previous years, this year's Yap Day celebrations included traditional and cultural activities, demonstrations of local food cooking, handicraft making, and lei-making.

Other cultural activities that were sponsored by the state's Department of Education included copra husking for boys and basket weaving for girls. Students from elementary schools participated in these competitions and won prizes.

Agricultural activities were also part of the celebration. The committee presented awards to the people who had the best produce and crops such as various types of yam and banana.

Marine Protected Areas (MPAs) essay contest winners were also recognized. Essay contests were sponsored by the office of Marine Resources to increase awareness of the importance of MPAs in Yapese waters.

Perhaps the highlight of this year's Yap Day, like every year, was the performances of Yapese traditional dances. This year was no exception as the crowd quickly gathered near the performing area or malal to see the

dances. While the dances often draw the Yapese audience, visiting folks from elsewhere enjoy this opportunity to take pictures of the most important part of the celebration.

The traditional dances on the two days were bamboo dances or gamel' from Weloy and Gilman municipalities, women's sitting dance from Maap and Kanifay municipalities, and men's dance or gaslaw from Tomil and Maap municipalities.

Yap Day celebrations this year also included Japanese and Filipino dance presentations. While these presentations were held at the community center rather than the museum site, a crowd still gathered to witness these performances. According to one Yap Day committee member, the inclusion of these foreign dances in the program was a result of the Japanese and Filipino requests to contribute to Yap Day celebrations.

Visitors who had come from afar said they enjoyed attending Yap Day celebrations.

One non-Yapese spectator who had attended Yap Day twice before said it would have been better if Yap Day had been held in the village because it looked more traditional that way.

Others commented on the convenience of the location, how it was easy to commute to the Yap Day site.

A member of the Yap Day committee said the event was "well-organized for a last minute thing." He added that aside from the traditional dance participants only a handful of Yapese dressed in their local attire.

Yap Day celebrations are held every year in the first day(s) of March, sometimes beginning in the last day(s) of February. This celebration of Yapese cultures and traditions has occurred for over four decades. The next one will be in 2013.

to celebrate International Women's Day. Many say that the crowd was the largest gathered for any event ever held at the gym; a claim that is likely to be true; even elbow room was hard to get. Whether or not it was the largest event ever held at the gym, organizers say that it certainly was the largest crowd ever assembled for the International Women's Day celebration.

Santos said that the record crowd was largely attributable to the increase in the number of women's groups in Pohnpei. "I think March 8th really excites everyone in the family," she wrote in an email. "From father to youngest child in the household, it's fun to go see mommy and sister dance their heart out on that one special day set aside for all women around the world."

The theme for this year's Women's Day, "Connecting Girls Inspiring Futures" was set by the United Nations and though Pohnpei was free to choose its own theme it chose to adopt the UN theme. In Pohnpei the events of the celebration did not seem to a casual observer to drive the theme home though there were an impressive number of groups this year that involved young people. Lululeen Santos who has been the Women's Interest Coordinator of Pohnpei's Office of Social Affairs since July of last year said that one might consider the event to have been a sort of kick off for activities under the stated theme; events that will happen during the rest of the year.

The celebration featured marathon dance performances by 26 women's groups listed on the program and one that was not. Even if the groups had limited their performances to ten minutes each and, even if performers were immediately ready to go when it was time to perform, neither of which was the case on Thursday, it would have taken four and a half hours just for the dancing performances. The crowd began to wane by mid-afternoon only to be replaced by hundreds of others; men, women, boys and girls; although the fact that men and boys were in attendance in large numbers seemed to have been forgotten by at least some of the women who commandeered the only men's restroom, forcing some of the not so fairer sex to take a hike into the surrounding foliage.

The social networking site, Facebook is crawling with photographs and videos taken by people who were present at the celebration and though most of the status postings we saw contained happy



congratulatory messages, some were a bit more cynical. Some postings expressed the sentiment that if women's groups would put as much effort into women's issues as they put into their dance routines they would be running the world by now.

But then the International Women's Day celebration is only the most visible activity of the women's groups; a gathering of all involved women at the same place at the same time. Santos said that the dancing is merely a celebration of the accomplishments of Pohnpei women over the course of the previous year and a time to fire up for the work they will do in the following year.

Last year saw the addition of new women's groups in Pohnpei, women who do far more than just dance, and this year the Pohnpei Women's Council is adding the Pohnpei Women's Disability Organization, and the Filipino Women's Community Organization. The latter group performed a cultural fan dance at Thursday's celebration that had not been listed on the program.

Santos said that for three years in a row the Pohnpei Women's Advisory Council has organized a beautification and cleaning project. "It really shows in each community," she wrote. "Men and women who aren't in a women's organization have gotten themselves involved with this cleaning project and that is what it's really about, involving all, not just women."

Though organizers decided not to judge this year's dance performances so that those performances would be just for fun, there was a competition amongst the 27 participating women's groups on the results of their cleaning campaigns. The

contest was judged, as it has been each year, by staff members of the Environmental Protection Agency. Santos said that the three winning groups for this year's competition were Lielehle PohnSapw of Pohnpei, Sapwafik in third place. Otoh Birthday Club of Awak, U came in second place for their efforts. Enipein Marine Park Women's Association from Enipein, Kittie earned the top prize.

"All of the women's groups participated and all of them cleaned up their own respective communities," Santos reminded.

But cleaning isn't all the women's groups are about.

In November of last year all the groups participated in the 16 day Action on Gender Violence activism program and there is currently pending legislation in Pohnpei that would be an opening foray to begin to curb the problem of gender based and domestic violence in Pohnpei.

Last month women's groups participated in trainings regarding leprosy. Santos said that this year each woman's group will be conducting trainings on the leprosy health matter in each of their communities.

In June there will be a Mother Daughter Weaving Competition. It's just one of the many activities that are being planned and several others are still on the drawing board.

Thursday's celebration was scheduled to begin at 9:00 AM sharp; "no Pohnpei time allowed," one of the organizers promised with a wink on the day before the event. But by as late as 10:00 some of the dignitaries still had not yet arrived.

The event got off to a soft start with a procession of the women, each group carrying a banner with the name of their group. By the time the women and girls were all assembled; jammed in on the floor like sardines in a can, there was very little room left and the gymnasium was nearly bursting at the seams.

Highlights of the opening included a performance of the State Anthem by 12 year old Jenna Panuelo followed by a lengthy but apparently very funny speech by Pohnpei Women's Advisory Council President Susanna Sohs. Lt. Governor Marcello Peterson, who was called that morning to substitute for Governor Ehsa who was not well, also gave a challenging and supportive speech. The women's group Lien Alem led the audience in a popular hymn before the first dancing group hit the floor.

"It was a long day! I didn't get home until almost 8:00," said one performer whose group was the 26th to perform. "Still, it was a lot of fun," she said with a twinkle in her eyes.

"I know that the people, the community and everyone else is finally understanding more and seeing that International Women's Day is not just about the dancing but about celebrating the accomplishment of the Pohnpeian women," Santos wrote.

She said that besides the celebratory benefit of the day's celebrations there was also a side health benefit for the women who participated. "From the time women start practicing for March 8 events, they are promoting healthy lifestyles. Practicing the dances is real exercise," she wrote. "Some women don't even realize it but they actually became healthier. Exercise can be not so fun but dancing is real fun and these women would rather dance than exercise."

If one considers the events on International Women's Day for what they are, a celebration of women rather than the sum of all women's activities in the State, the event was successful beyond expectation. Now, if the women's groups do in fact, continue to put as much effort into women's issues as they did into their dance performances, the events of March 8, 2012 may be a harbinger of great positive changes for the circumstances of women in Pohnpei. Where women are healthy and respected the whole of society thrives.

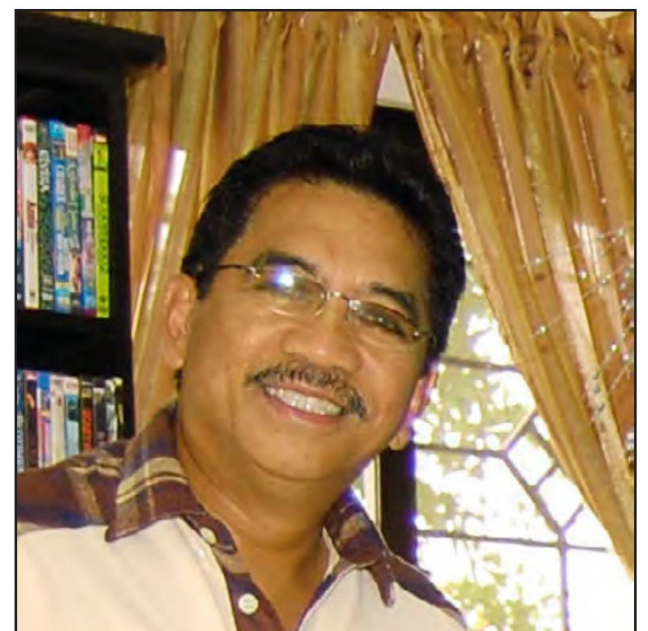

Currently, GEAR UP students are also participating in the Australian funded "Middle school science program and expo".

GEAR UP also trains local teachers in curriculum development, lesson planning, and creating programming at the schools to increase student attendance, grades, and expose youth to enrichment activities.

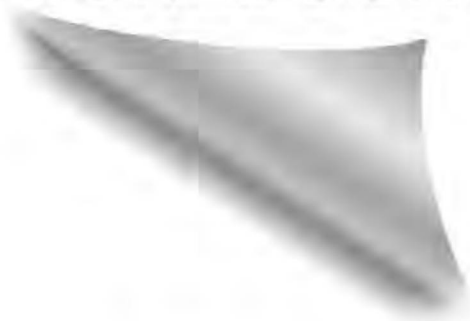
teachers, coaches, friends, and family members.

Economic Tools for Conservation in Micronesia

Conservation Strategy Fund's Economic Tools for Conservation training course will be offered at the College of Micronesia – FSM, from March 12-13, 2012 in Pohnpei, Micronesia. The course is being offered in partnership with the Micronesian Conservation Trust (MCT) and thanks to the generous grants from the David and Lucile Packard Foundation, NZAID's Pacific Island Country Participation Fund and OneReef.

After Willy Kostka, Executive Director of the MCT, completed the course in 2010 at Stanford University, he invited the course to Micronesia and has since been working with Kim Bonine of CSF to make this happen. This course will be CSF's first, and hopefully not the last, in the Western Pacific region.

Instructors for the course include David Johnson of Harvard University, Padma Lal, a visiting scientist at the Commonwealth Scientific and Industrial Research Organization (CSIRO) of Australia, Nicholas Conner with the New South Wales Office of Environment and Heritage, Chris LaFranchi of OneReef, and Kim Bonine of CSF.

The training will support conservation of marine and forest resources in Micronesia by equipping conservation practitioners, natural resource managers and community leaders with the principles and tools of conservation economics.

The thousands of islands comprising Micronesia are characterized by rich natural resources from both land and sea. However, this natural wealth is threatened by a series of interlocking challenges. Integration of the once-isolated islands in the region with global markets has led to rapid development. Coupled with population growth, this transition is placing increasing pressures on natural resources. Pollution, deforestation, infrastructure development, invasive species, deep-sea mining and over-fishing all threaten the region's ecosystems and future natural and economic health. Outside pressures, including global warming and foreign exploitation of fishery resources, are additional serious concerns for these island nations. Participants will leave the course with new economic knowledge and skills to evaluate these and key issues affecting the environment on their islands.

The training will include sessions on economic fundamentals, natural resource economics, fisheries management, environmental policy, environmental valuation, cost-benefit analysis, conservation agreements and communication and negotiation techniques. A workshop component will also be included to help participants develop concrete applications of these economic tools to issues such as fisheries management policies, incentives for coastal area protection, assessing the costs and benefits of infrastructure or tourism development, and estimating the benefits of ecosystem services provided by mangrove forests and coral reefs. More than 15 participants will be drawn from the Federated States of Micronesia, Marshall Islands, Palau, Guam, the Commonwealth of the Northern Mariana Islands and American Samoa.

Immediately following the training, MCT and CSF will work with course participants to implement several programs/projects across Micronesia, using the newly acquired knowledge and tools from the course.

Kudos to Paradise!

I love it when events that seem destined not to work, work anyway and in stellar fashion! The “Music Box 2012” fundraising event last Saturday evening at the Rusty Anchor Pub and Grub, put on by Paradise Media which operates V6W1, FM 89.5 Paradise Radio was one of those types of events.

I admit freely and in my most shamefaced, “crow-eating” fashion, that I expected the event to fall flat on its face. I had questions:

How would “Paradise” attract a reasonably sized crowd given that the time for promotion between completion of venue negotiations and the event itself was extremely short; only about two weeks?

Second, I, as a cantankerous middle aged man, wondered how the organizers who were mostly “twenty somethings” (one of whom was my son) could pull off the large scale event they envisioned. (I must admit and I do so, freely now, that I completely forgot that all of my childhood rock star heroes were “twenty somethings,” and that I organized my first large scale event when I was a “twenty something.” Now just how embarrassing is that for an old man to admit?)

Third, if a large crowd did show up at the event how would the organizers keep the irascible (violently inclined) few from causing a disaster of epic proportions at Rusty Anchor, the one venue where my band, “Wetter than Seattle” frequently and almost exclusively performs and, what would such a disaster mean for the future of the radio station?

I had many other questions and though I knew that the organizers met nearly every night for weeks to make the event work, even before they knew where it would be, I just wasn’t convinced that it would work until the event itself was well under way.

My fears that no one would show were unfounded as were most of my other fears. Rusty Anchor Pub and Grub was jam packed inside and out with fans ranging in age from teenagers to self proclaimed, “Old fogies.”

The event wasn’t scheduled to start until 8:00 and for the first hour it was just going to be a bit of music to keep the crowd happy before the first artist performed at 9:00. At 7:15 there was already a line at the door.

One of my fears was that there would be under-aged drinking and that problem might be a huge legal ordeal for the owners of Rusty Anchor—didn’t happen. I was even more

afraid that underage (or even legal age) drinking, or perhaps clashes of generations or cultures might spark fights—also, didn’t happen.

Maybe the security pat downs at the entrance set the tone, I don’t know, but those in attendance, even the young ones who were not allowed into the bar without parental guidance seemed to know what was expected.

Some parents did accompany their teen aged children to the event. The bass guitar player for “Wetter than Seattle” later commented that it must have been every daughter’s nightmare to go on her first date, which happened on that Saturday night, and have her dad be a member of “the band.” I would bet she was actually proud to have such a “cool” dad. other serious health problems, amputations of toes, feet and legs, kidney failure and even death.

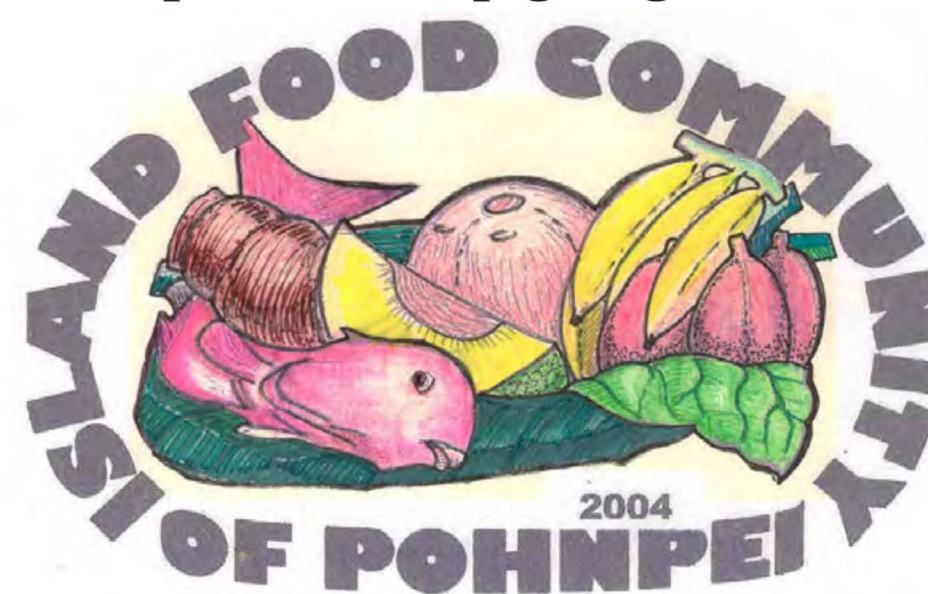
The other benefits of membership are:

and National Olympic Committee (NOC) at Palm Terrace parking lot in Kolonia, Pohnpei.

Island Food Community of Pohnpei (IFCP) provided yellow flesh local fruits: Karat, Pohnpei State Banana, and Pandanus.

Yellow flesh local fruits and crops such as banana, pandanus, taro, and breadfruits are high in beta carotene, provitamin A. Beta carotene turns into vitamin A inside the body.

High contents of beta carotene as well as total carotenoid, other vitamins, minerals and fiber in local food can help people fight against diabetes, heart disease, certain cancers, vitamin A deficiency and anemia.

IFCP believes that health crisis in FSM, one in three adult has diabetes, is due to changes in diet (consuming more imported unhealthy food rather than healthy own local food) and lack of exercise. Going local (planting, growing, maintaining, harvesting, cooking and eating local food) will nourish you well and provide enough

exercise, thus make you healthy.

Fun Run/Walk is a good opportunity to start daily exercise. Come and join FUN Run/Walk once a month and gradually make it as your weekly or daily routine.
